## **Findings and Decision**

This medical fee dispute is decided according to <u>Texas Labor Code §413.031</u> and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation (DWC).

### **Statutes and Rules**

1. 28 Texas Administrative Code (TAC) §133.307 sets out the procedures for resolving medical fee disputes.

### **Denial Reasons**

The insurance carrier [reduced or denied] the payment for the disputed services with the following claim adjustment codes:

- CAC-W3 In accordance with TDI-DWC Rule 134.804, this bill has been identified as a request for reconsideration or appeal
- CAC-193 Original payment decision is being maintained. Upon review, it was determined that this claim was processed properly
- CAC-29 The time limit for filing has expired
- DC4 No additional reimbursement allowed after reconsideration. For information call (888) 532-5248
- 350 In accordance with TDI-DWC Rule 134.804, this bill has been identified as a request for reconsideration or appeal
- 731 Per 133.20(B) Provider shall not submit a medical bill later than the 95<sup>th</sup> day after the date the service
- 928 HCP must submit documentation to support exception to timely filing of bill (408.0272). Notification of erroneous submission not included

#### Issues

1. Did the requestor waive the right to medical fee dispute resolution?

## **Findings**

1. 28 Texas Administrative Code §133.307(c)(1) states:

Timeliness. A requestor must timely file the request with the division or waive the right to MFDR. The division will deem a request to be filed on the date the division receives the request. A decision by the division that a request was not timely filed is not a dismissal and may be appealed pursuant to subsection (g) of this section.

(A) A request for MFDR that does not involve issues identified in subparagraph (B) of this paragraph shall be filed no later than one year after the date(s) of service in dispute.

The date of the services in dispute is March 11, 2022. The request for medical fee dispute resolution was received on May 22, 2023. This date is later than one year after the date(s) of service in dispute. Review of the submitted documentation finds that the disputed services do not involve issues identified in §133.307(c)(1)(B). The Division concludes that the requestor has

failed to timely file this dispute; consequently, the requestor has waived the right to medical fee dispute resolution.

### **Conclusion**

The outcome of this medical fee dispute is based on the evidence presented by the requestor and the respondent at the time of adjudication. Though all evidence may not have been discussed, it was considered.

DWC finds that no additional reimbursement is due.

### Order

Under Texas Labor Code §§413.031 and 413.019, DWC has determined the requestor is not entitled to additional reimbursement for the disputed services.
