# **Requestor's Position**

"FCE's are billed in 15 minute increments and displayed as such on the units column of the HCFA. Each unit is billed accordingly based on Medical Fee Guideline conversion factors as established by DWC rule. The claim was billed per Medical Fee Guideline conversion factors as established in Rule 134.203 (c) (2). The DWC Division Ratio/conversation factors for the date of service billed are utilized for this claim."

Amount in Dispute: \$67.22

# **Respondent's Position**

"The service in question is an FCE under CPT code 97750. The provider billed \$317.15. The provider acknowledged that the carrier had reimbursed him the amount of \$249.93. The provider is seeking additional payment of \$67.22. We are attaching a copy of the provider's CMS 1500 and the carrier's EOR dated June 9, 2023. The carrier's position remains the same."

## **Findings and Decision**

#### <u>Authority</u>

This medical fee dispute is decided according to <u>Texas Labor Code §413.031</u> and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation (DWC).

#### Statutes and Rules

- 1. 28 Texas Administrative Code (TAC) §133.307 sets out the procedures for resolving medical fee disputes.
- 2. 28 TAC §134.203 sets out the fee guideline for professional medical services.
- 3. 28 TAC §134.210 applied to fee guidelines for division-specific services.
- 4. 28 TAC §134.225 sets the reimbursement guidelines for FCEs.

#### **Adjustment Reasons**

The insurance carrier reduced the payment for the disputed services with the following claim adjustment codes:

- 163 THE CHARGE FOR THIS PROCEDURE EXCEEDS THE UNIT VALUE AND/OR THE MULTIPLE PROCEDURE RULES.
- 119 BENEFIT MAXIMUM FOR THIS TIME PERIOD OR OCCURRENCE HAS BEEN REACHED.
- 1014 The attached billing has been re-evaluated at the request of the provider. Based on this re-evaluation, we find our original review to be correct. Therefore, no additional allowance appears to be warranted.
- 947 UPHELD. NO ADDITIONAL ALLOWANCE HAS BEEN RECOMMENDED.
- 193 ORIGINAL PAYMENT DECISION IS BEING MAINTAINED. UPON REVIEW, IT WAS DETERMINED THAT THIS CLAIM WAS PROCESSED PROPERLY.
- W3 BILL IS A RECONSIDERATION OR APPEAL.
- MA46 Alert: The new information was considered but additional payment will not be issued.

#### Issues

- 1. Is the insurance carrier's payment reduction reason supported?
- 2. Is the requestor entitled to additional reimbursement for 97750-FC rendered on May 30, 2023?

### **Findings**

1. The requestor billed \$317.15 for 5 units of a functional capacity evaluation (FCE) rendered on date of service May 30, 2023, using CPT code 97750-FC. The insurance carrier reduced reimbursement for disputed service based on reason code 163, defined above.

28 TAC §134.225 states: "The following applies to functional capacity evaluations (FCEs) ... FCEs shall be billed using CPT code 97750 with modifier 'FC.' FCEs shall be reimbursed in accordance with §134.203(c)(1) of this title."

Per 28 TAC §134.203 (b)(1), parties are required to apply Medicare payment policies, including its coding, billing, correct coding initiatives (CCI) edits, modifiers, and other payment policies in effect on the date a service is provided with any additions or exceptions in the rules to workers' compensation coding, billing, reporting, and reimbursement of professional medical services.

28 TAC §§134.203 (a)(7) and 134.210 (a) state that specific provisions contained in the Texas Labor Code or division rules shall take precedence over any conflicting provision adopted or utilized by CMS in administering the Medicare program. However, no such conflict regarding billing or reimbursement was found that applies to a division-specific functional capacity evaluation. Therefore, Medicare reimbursement rules are applied to the examination in question.

Per Medicare Claims Processing Manual (cms.gov), Chapter 5, 10.7, effective February 6, 2019:

Medicare applies a multiple procedure payment reduction (MPPR) to the practice expense (PE) payment of select therapy services. The reduction applies to the HCPCS codes contained on the list of "always therapy" services ...

Many therapy services are time-based codes, i.e., multiple units may be billed for a single procedure ...

Full payment is made for the unit or procedure with the highest PE payment ... For subsequent units and procedures with dates of service on or after April 1, 2013, furnished to the same patient on the same day, full payment is made for work and malpractice and 50 percent payment is made for the PE for services submitted on either professional or institutional claims.

Procedure code 97750 is classified as "always therapy" in the 2022 Therapy Code List and Dispositions found in the <u>Annual Therapy Update | CMS</u>. Therefore, the MPPR applies to the reimbursement of this code.

The division finds that the insurance carrier's reimbursement reduction reason is supported.

2. On the disputed date of service, the requestor billed CPT code 97550-FC X 5 units.

As described above, the MPPR rule applies to the disputed service.

The MPPR Rate File that contains the payments for 2023 services is found at <a href="https://www.cms.gov/Medicare/Billing/TherapyServices/index.html">www.cms.gov/Medicare/Billing/TherapyServices/index.html</a>.

To determine the maximum allowable reimbursement (MAR) the following formula is used: (DWC Conversion Factor/Medicare Conversion Factor) X Medicare Payment = MAR.

- MPPR rates are published by carrier and locality.
- The disputed date of service is May 30, 2023.
- The disputed service was rendered in zip code 79761, locality 99, "Rest of TX".
- The Medicare participating amount for CPT code 97750 at this locality in 2023 is \$33.21 for the first unit, and \$24.36 for subsequent units.

- The 2023 DWC Conversion Factor is 64.83
- The 2023 Medicare Conversion Factor is 33.8872
- Using the above formula, the DWC finds the MAR for the first unit is \$63.53 and \$46.60 for each subsequent 4 units.
- The MAR for 5 units of 97750-FC in locality 99 in 2023 = \$249.94.
- The respondent paid \$249.93.
- No additional reimbursement is recommended.

#### **Conclusion**

The outcome of this medical fee dispute is based on the evidence presented by the requestor and the respondent at the time of adjudication. Though all evidence may not have been discussed, it was considered.

The division finds that the requestor has not established that additional reimbursement is due.

#### Order

Under Texas Labor Code §§413.031 and 413.019, DWC has determined the requestor is entitled to \$0.00 additional reimbursement for the disputed service.
