Requestor's Position

The requestor did not submit a position statement with this request for Medical Fee Dispute Resolution (MFDR). They did submit a document titled "Reconsideration" addressed to the Texas Department of Insurance that states, "Per EOB received payment was disallowed to Rev code 278 for implants. Please note that separate reimbursement was not requested for implants, and per TX fee schedule CPT code 29827 should be paid at 200% GARR."

Amount in Dispute: \$4,508.56

Respondent's Position

"Please see the attached EOBs. The Carrier has paid a total of \$4,508.56. This amount was inclusive of the entire surgical procedure, the APC rate plus the markup. Additionally, Requestor did not provide implant invoices equal the amount they billed. In conclusion, Requestor is not

owed any additional reimbursement for the surgical procedure."

Findings and Decision

<u>Authority</u>

This medical fee dispute is decided according to <u>Texas Labor Code §413.031</u> and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation (DWC).

Statutes and Rules

- 1. <u>28 TAC §133.307</u> sets out the procedures for resolving medical fee disputes.
- 2. <u>28 TAC §134.403</u> sets out the fee guidelines for outpatient hospital services.

Denial Reasons

The insurance carrier reduced the payment for the disputed services with the following claim adjustment codes:

- 252 An attachment/other documentation is required to adjudicate this claim/service.
- P12 Workers' compensation jurisdictional fee schedule adjustment.
- 253 In order to review this charge please submit a copy of the certified invoice.
- 350 Bill has been identified as a request for reconsideration or appeal.
- 370 This hospital outpatient allowance was calculated according to the APC Rate, plus a markup.
- 618 The value of this procedure is packaged into the payment of other services performed on the same date of service,
- W3 In accordance with TDI-DWC Rule 134.804, this bill has been identified as a request for reconsideration or appeal.

<u>lssues</u>

- 1. Did the requestor seek separate reimbursement of implants?
- 2. What rule is applicable to reimbursement?
- 3. Is the requester entitled to additional reimbursement?

<u>Findings</u>

1. The requestor is seeking additional payment of outpatient hospital services rendered in March 2023. The insurance carrier paid at a reduced rate as if a request for separate payment for implants was made. DWC Rule 28 TAC §133.10 (2)(QQ) states, "remarks (UB-04/field 80) is required when separate reimbursement for surgically implanted devices is requested,"

Review of the submitted medical bill found a request for separate reimbursement of the implants was not made. The reduced payment is not supported. The service in dispute will be reviewed per applicable fee guideline.

2. DWC Rule 28 TAC §134.403 (d) requires Texas workers' compensation system participants when coding, billing, reporting and reimbursement to apply Medicare payment policies in effect on the date of service.

The Medicare payment policy applicable to the services in dispute is found at <u>www.cms.gov</u>, Claims processing Manual, Chapter 4, Section 10.1.1. Specifically, Payment Status Indicators and Ambulatory Payment Category (APC).

DWC Rule 28 TAC 134.403 (e) states in pertinent part, regardless of billed amount, when no specific fee schedule or contract reimbursement shall be the maximum allowable reimbursement (MAR) amount under subsection (f) of this section including any applicable outlier payment amounts and reimbursement for implantables.

DWC Rule 28 TAC 134.403 (f) states in pertinent part the reimbursement calculation used for establishing the MAR shall be the Medicare facility specific amount, including outlier payment amounts, determined by applying the most recently adopted and effective Medicare Outpatient Prospective Payment System (OPPS) reimbursement formula and factors as published annually in the *Federal Register*.

The Medicare facility specific amount is calculated when the APC payment rate is multiplied by 60% to determine the labor portion. This amount is multiplied by the facility wage index for the date of service. The non-labor amount is determined when the APC payment rate is multiplied by 40%. The sum of the labor portion multiplied by the facility wage index and the non-labor portion determines the Medicare specific amount. Review of the submitted medical bill and the applicable fee guidelines referenced above is shown below.

• Procedure code 29827 has status indicator J1, for procedures paid at a comprehensive rate. This procedure is the highest ranking J1 procedure and is the only claim line payable.

This code is assigned APC 5114. The OPPS Addendum A rate is \$6,614.63 multiplied by 60% for an unadjusted labor amount of \$3,968.78, in turn multiplied by facility wage index 0.9562 for an adjusted labor amount of \$3,794.95.

The non-labor portion is 40% of the APC rate, or \$2,645.85.

The sum of the labor and non-labor portions is \$6,440.80.

The Medicare facility specific amount is \$6,440.80 multiplied by 200% for a MAR of \$12,881.60.

3. The total recommended reimbursement for the disputed services is \$12,881.60. The insurance carrier paid \$8,373.04. The amount due is \$4,508.56. This amount is recommended.

Conclusion

The outcome of this medical fee dispute is based on the evidence presented by the requestor and the respondent at the time of adjudication. Though all evidence may not have been discussed, it was considered.

DWC finds the requester has established that additional reimbursement is due.

Order

Under Texas Labor Code §§413.031 and 413.019, DWC has determined the requestor is entitled to additional reimbursement for the disputed services. It is ordered that Amtrust Insurance Co must remit to Baylor Orthopedic & Spine Hospital \$4,508.56 plus applicable accrued interest within 30 days of receiving this order in accordance with 28 TAC §134.130.

Your Right to Appeal

Either party to this medical fee dispute has a right to seek review of this decision under 28 TAC §133.307, which applies to disputes filed on or after **June 1, 2012**.

A party seeking review must submit DWC Form-045M, *Request to Schedule, Reschedule, or Cancel a Benefit Review Conference to Appeal a Medical Fee Dispute Decision (BRC-MFD)* and follow the instructions on the form. You can find the form at <u>www.tdi.texas.gov/forms/form20numeric.html</u>. DWC must receive the request within **20 days** of when you receive this decision. You may fax, mail, or personally deliver your request to DWC using the contact information on the form or the field office handling the claim.
