

MDR: Tracking Number M5-02-2215-01

Under the provisions of Section 413.031 of the Texas Workers' Compensation Act, Title 5, Subtitle A of the Texas Labor Code, effective January 1, 2002 and Commission Rule 133.305 and 133.308 titled Medical Dispute Resolution by Independent Review Organizations, the Medical Review Division assigned an IRO to conduct a review of the disputed medical necessity issues between the requestor and the respondent.

The Medical Review Division has reviewed the IRO decision and determined that **the requestor prevailed** on the issues of medical necessity. Therefore, upon receipt of this Order and in accordance with §133.308(q)(9), the Commission hereby orders the respondent and non-prevailing party to **refund the requestor \$450.00** for the paid IRO fee. For the purposes of determining compliance with the order, the Commission will add 20 days to the date the order was deemed received as outlined on page one of this order.

In accordance with §413.031(e), it is a defense for the carrier if the carrier timely complies with the IRO decision.

Based on review of the disputed issues within the request, the Medical Review Division has determined that **medical necessity was the only issue** to be resolved. The office visits, therapeutic procedures and application modalities were found to be medically necessary. The respondent raised no other reasons for denying reimbursement for these office visits, therapeutic procedures and application modality charges.

This Order is applicable to dates of service from 12/7/01 through 12/14/01 in this dispute.

The respondent is prohibited from asserting additional denial reasons relative to this Decision upon issuing payment to the requestor in accordance with this Order (Rule 133.307(j)(2)).

Clinical History:

This 44-year-old male claimant suffered a work-related injury on ___.

Disputed Services:

Office visits, therapeutic procedures, and application modalities during the period of 12/01/01 through 12/14/01.

Rationale:

Based on both the patient's objective MRI results of impingement syndrome, and continued subjective complaints from the patient, the reviewer found that the care given was both necessary and medically appropriate. All care received supported the full-time return-to-work status of the patient, indicating successful care was given.
