NOTICE OF INDEPENDENT REVIEW DECISION

November 1, 2002

Re: IRO Case # M2-03-0212-01

Texas Worker's Compensation Commission:

___ has been certified as an independent review organization (IRO) and has been authorized to perform independent reviews of medical necessity for the Texas Worker's Compensation Commission (TWCC). Texas HB. 2600, Rule133.308 effective January 1, 2002, allows a claimant or provider who has received an adverse medical necessity determination from a carrier's internal process, to request an independent review by an IRO.

In accordance with the requirement that TWCC assign cases to certified IROs, TWCC assigned this case to ___ for an independent review. ___ has performed an independent review of the proposed care to determine if the adverse determination was appropriate. For that purpose, ___ received relevant medical records, any documents obtained from parties in making the adverse determination, and any other documents and/or written information submitted in support of the appeal.

The case was reviewed by a physician who is Board Certified in Psychiatry. He or she has signed a certification statement attesting that no known conflicts of interest exist between him or her and any of the treating physicians or providers, or any of the physicians or providers who reviewed the case for a determination prior to referral to ___ for independent review. In addition, the certification statement further attests that the review was performed without bias for or against the carrier, medical provider, or any other party to this case.

The determination of the ___ reviewer who reviewed this case, based on the medical records provided, is as follows:

History

The patient is a 41-year-old male diagnosed with Post Traumatic Stress Disorder, Panic Attacks and Major Depression, who was evaluated by a psychologist, and who has seen a psychiatrist as an outpatient. He has been prescribed Xanax, Paxil and Wellbutrin. The patient was injured in ___, when an elevator came down on him while he was on a ladder. In addition to physical injury, the patient has had panic reactions, nightmares, crying spells, sleep disturbance and frequent anxious recall of the event. His partner at home is disabled and wheelchair bound.

Requested Service

The psychologist requested approval for 45-50 sessions on a twice a week schedule using cognitive, dynamic, insight-oriented and supportive therapy.

Decision

I disagree with the carrier's decision to deny the requested treatment.

Rationale

The proposed treatment plan and methods of therapy are entirely appropriate for this patient. A case such as this involving PTSD and Major Depression should respond to six months of twice a week psychotherapy as has been proposed.

This medical necessity decision by an Independent Review Organization is deemed to be a Commission decision and order.

YOUR RIGHT TO REQUEST A HEARING

Either party to this medical dispute may disagree with all or part of the decision and has a right to request a hearing.

If disputing a spinal surgery prospective decision, a request for a hearing must be in writing, and it must be received by the TWCC Chief Clerk of Proceedings within **10** (ten) days of your receipt of this decision (28 Tex. Admin. Code 142.5(c)).

If disputing other prospective medical necessity (preauthorization) decisions, a request for a hearing must be in writing, and it must be received by the TWCC Chief Clerk of Proceedings within **20** (twenty) days of your receipt of this decision (28 Tex. Admin. Code 148.3).

This decision is deemed received by you 5 (five) days after it was mailed (28 Tex. Admin. Code 102.4(h) or 102.5(d)). A request for a hearing should be sent to:

The party appealing this decision shall deliver a copy of its written request for a hearing to all other parties involved in the dispute (Commission Rule 133.308(t)(2)).
