

NOTICE OF INDEPENDENT REVIEW DETERMINATION

An independent review of the above-referenced case has been completed by a medical physician board certified in family practice. The appropriateness of setting and medical necessity of proposed or rendered services is determined by the application of medical screening criteria published by ____, or by the application of medical screening criteria and protocols formally established by practicing physicians. All available clinical information, the medical necessity guidelines and the special circumstances of said case was considered in making the determination.

CLINICAL HISTORY

This patient sustained a work related back injury on ____. He had extensive treatments including medications, physical therapy, lumbar injections, and, ultimately, surgery. A request to purchase a muscle stimulator was denied as was an appeal.

REQUESTED SERVICE(S)

Purchase of an interferential muscle stimulator.

DECISION

Uphold denial.

RATIONALE/BASIS FOR DECISION

Insufficient clinical information and lack of peer review literature to support the use of a muscle stimulator for post-surgical patients justify the denial to purchase this device for this patient. Standard of care and accepted literature and guidelines support the use of a muscle stimulator for patients during the acute phase of treatment; not chronic pain, post-surgical patients. Therefore, the original decision to deny the purchase of this device is upheld.

YOUR RIGHT TO REQUEST A HEARING

Either party to this medical dispute may disagree with all or part of the decision and has a right to request a hearing.

If disputing a spinal surgery prospective decision a request for a hearing must be in writing, and it must be received by the TWCC Chief Clerk of Proceedings within **10** (ten) calendar days of your receipt of this decision (20 Tex. Admin. Code 142.5©).

If disputing other prospective medical necessity (preauthorization) decisions a request for a hearing must be in writing, and it must be received by the TWCC Chief Clerk of Proceedings within **20** (twenty) calendar days of your receipt of this decision (28 Tex. Admin. Code 148.3).

This decision is deemed received by you 5 (five) days after it was mailed or the date of fax (28 Tex. Admin. Code 102.4(h) or 102.5(d)). A request for a hearing and a **copy of this decision** must be sent to:
