CLINICAL HISTORY

A 44-year-old female injured in an MVA ___ while driving an employers rental car to meet a client. Patient ultimately underwent C6-7 and C7-T1 ACDF 4/24/03. She suffered residual bilateral neck and trapezius region pain, right worse than left.

REQUESTED SERVICE (S)

Botulinum toxin chemodenervation upper extremity and cervical paraspinal muscles.

DECISION

Approved.

RATIONALE/BASIS FOR DECISION

Follow-up visit notes including history and examination strongly suggests continued muscle spasms. There is adequate documentation in the literature that botulism toxin chemodenervation would likely be quite helpful for this type of continued muscle spasm.

YOUR RIGHT TO REQUEST A HEARING

Either party to this medical dispute may disagree with all or part of the decision and has a right to request a hearing.

If disputing a spinal surgery prospective decision a request for a hearing must be in writing, and it must be received by the TWCC Chief Clerk of Proceedings within **10** (ten) calendar days of your receipt of this decision (20 Tex. Admin. Code 142.5©).

If disputing other prospective medical necessity (preauthorization) decisions a request for a hearing must be in writing, and it must be received by the TWCC Chief Clerk of Proceedings within **20** (twenty) calendar days of your receipt of this decision (28 Tex. Admin. Code 148.3).

This decision is deemed received by you 5 (five) days after it was mailed or the date of fax (28 Tex. Admin. Code 102.4(h) or 102.5(d)). A request for a hearing and a **copy of this decision** must be sent to:
