NOTICE OF INDEPENDENT REVIEW DECISION

January 6, 2004

Re: IRO Case # M2-04-0552-01

Texas Worker's Compensation Commission:

___ has been certified as an independent review organization (IRO) and has been authorized to perform independent reviews of medical necessity for the Texas Worker's Compensation Commission (TWCC). Texas HB. 2600, Rule 133.308 effective January 1, 2002, allows a claimant or provider who has received an adverse medical necessity determination from a carrier's internal process, to request an independent review by an IRO.

In accordance with the requirement that TWCC assign cases to certified IROs, TWCC assigned this case to ___ for an independent review. ___ has performed an independent review of the proposed care to determine if the adverse determination was appropriate. For that purpose, ___ received relevant medical records, any documents obtained from parties in making the adverse determination, and any other documents and/or written information submitted in support of the appeal.

The case was reviewed by a physician who is Board Certified in Neurological Surgery, and who has met the requirements for the TWCC Approved Doctor List or who has been granted an exception from the ADL. He or she has signed a certification statement attesting that no known conflicts of interest exist between him or her and any of the treating physicians or providers, or any of the physicians or providers who reviewed the case for a determination prior to referral to ___ for independent review. In addition, the certification statement further attests that the review was performed without bias for or against the carrier, medical provider, or any other party to this case.

The determination of the ___ reviewer who reviewed this case, based on the medical records provided, is as follows:

History

The patient is a 40-year old female who in ___ was lifting tires over her head when the tires fell, striking her in the neck and causing a twisting of her neck and low back. The patient developed neck and low back pain that has persisted. The primary pain is now in the patient's neck, and it has persisted despite conservative management. The patient has a history of anterior cervical discectomy and fusion some 11 years ago at the C6-7 level. An MRI on 2/8/02 showed some question of the fusion not being adequate at C6-7, and also possible disk rupture at C5-6 on the right side. EMG has revealed evidence of multiple areas of radiculopathy.

Requested Service(s)

Repeat MRI of the cervical spine

Decision

I disagree with the carrier's decision to deny the requested MRI.

Rationale

The patient has changes on her MRI evaluation two years ago that are compatible with her symptoms and are potentially surgically correctable. The patient is a surgical candidate, and a surgeon would be frowned upon if he did not obtain a repeat MRI before pursuing surgery. Therefore, a repeat MRI is indicated.

This medical necessity decision by an Independent Review Organization is deemed to be a Commission decision and order.

YOUR RIGHT TO REQUEST A HEARING

Either party to medical dispute may disagree with all or part of the decision and has a right to request a hearing.

If disputing a spinal surgery prospective decision, a request for a hearing must be in writing, and it must be received by the TWCC Chief Clerk of Proceedings within **10** (ten) calendar days of your receipt of this decision (28 Tex. Admin. Code 142.5(c)).

If disputing other prospective medical necessity (preauthorization) decisions, a request for a hearing must be in writing, and it must be received by the TWCC Chief Clerk of Proceedings within **20** (twenty) calendar days of your receipt of this decision (28 Tex. Admin. Code 142.5(c)).

This decision is deemed received by you 5 (five) days after it was mailed or the date of fax (28 Tex. Admin. Code 102.5(d)). A request for a hearing and a **copy of this decision** must be sent to:
