

NOTICE OF INDEPENDENT REVIEW DECISION

The ___ has been certified by the Texas Department of Insurance (TDI) as an independent review organization (IRO). The Texas Workers' Compensation Commission (TWCC) has assigned the above referenced case to ___ for independent review in accordance with TWCC Rule §133.308 which allows for medical dispute resolution by an IRO.

___ has performed an independent review of the proposed care to determine if the adverse determination was appropriate. In performing this review, relevant medical records, any documents utilized by the parties referenced above in making the adverse determination, and any documentation and written information submitted in support of the appeal was reviewed.

The independent review was performed by a ___ physician reviewer who is board certified in Orthopedic Surgery, which is the same specialty as the treating physician. The ___ physician reviewer has signed a certification statement stating that no known conflicts of interest exist between him or her and any of the treating physicians or providers or any of the physicians or providers who reviewed the case for a determination prior to the referral to ___ for independent review. In addition, the reviewer has certified that the review was performed without bias for or against any party to this case.

Clinical History

This patient sustained an injury on ___ while lifting a file cabinet weighting approximately 250 pounds. He incurred a disc herniation at L4-5 and L5-S1. He underwent a lumbar laminectomy on 08/24/02 but continued to have pain and numbness. Over the past year, conservative therapies have included pain, muscle relaxant, and sedative medications, physical therapy, and epidural steroid injections.

Requested Service(s)

Lumbar discogram

Decision

It is determined that the proposed lumbar discogram is medically necessary to treat this patient's condition.

Rationale/Basis for Decision

This patient has had persistent pain and has been diagnosed with failed laminectomy syndrome. The patient has a long history of pain in his back and an attempt should be made to find its etiology. The discogram is medically indicated if the plan is to correct the problem once identified.

Discograms can and do help identify disease levels and assist in surgical planning if appropriate. Therefore, it is determined that the proposed lumbar discogram is medically necessary.

This decision by the IRO is deemed to be a TWCC decision and order.

YOUR RIGHT TO REQUEST A HEARING

Either party to this medical dispute may disagree with all or part of the decision and has a right to request a hearing.

If disputing a spinal surgery prospective decision a request for a hearing must be in writing and it must be received by the TWCC Chief Clerk of Proceedings within **10** (ten) calendar days of your receipt of this decision (28 Tex. Admin. Code 142.5 (c))

If disputing other prospective medical necessity (preauthorization) decisions a request for a hearing must be in writing, and it must be received by the TWCC Chief Clerk of Proceedings within **20** (twenty) calendar days of your receipt of this decision (28 Tex. Admin. Code 142.5(c)).

This decision is deemed received by you 5 (five) days after it was mailed or the date of fax (28 Tex. Admin. Code 102.5(d)). A request for hearing and a **copy of this decision** must be sent to: Chief Clerk of Proceedings/Appeals Clerk, Texas Workers' Compensation Commission, P.O. The party appealing this decision shall deliver a copy of its written request for a hearing to all other parties involved in this dispute.
