An independent review of the above-referenced case has been completed by a medical physician board certified in family practice. ___ sustained a work related knee injury on ___. He was treated with medications, physical therapy, surgery, a knee brace, injections, and a muscle stimulator. Also, he participated in an outpatient multidisciplinary pain program.

REQUESTED SERVICE(S)

Purchase of an IF muscle stimulator

DECISION

Denied.

RATIONALE/BASIS FOR DECISION

No objective evidence was submitted to prove the efficacy of this device for the patient. Furthermore, after the device was in use, there is documentation that his pain increased and he then entered a multidisciplinary pain program. Also, no

peer review literature or guidelines support the use of this device for chronic knee pain. Therefore, the purchase of this device is denied.

YOUR RIGHT TO REQUEST A HEARING

Either party to this medical dispute may disagree with all or part of the decision and has a right to request a hearing.

If disputing a spinal surgery prospective decision a request for a hearing must be in writing, and it must be received by the TWCC Chief Clerk of Proceedings within **10** (ten) calendar days of your receipt of this decision (20 Tex. Admin. Code 142.5©)

If disputing other prospective medical necessity (preauthorization) decisions a request for a hearing must be in writing, and it must be received by the TWCC Chief Clerk of Proceedings within **20** (twenty) calendar days of your receipt of this decision (28 Tex. Admin. Code 148.3)

This decision is deemed received by you 5 (five) days after it was mailed or the date of fax (28 Tex. Admin. Code 102.4(h) or 102.5(d)). A request for a hearing and a **copy of this decision** must be sent to:
