\_\_\_ has performed an independent review of the proposed care to determine if the adverse determination was appropriate. In performing this review, all relevant medical records and documentation utilized to make the adverse determination, along with any documentation and written information submitted, was reviewed.

The independent review was performed by a matched peer with the treating doctor. This case was reviewed by a licensed Doctor of Osteopathy board certified in anesthesiology and specialized in pain management. The reviewer is on the TWCC Approved Doctor List (ADL). The \_\_\_ health care professional has signed a certification statement stating that no known conflicts of interest exist between the reviewer and any of the treating doctors or providers or any of the doctors or providers who reviewed the case for a determination prior to the referral to \_\_\_ for independent review. In addition, the reviewer has certified that the review was performed without bias for or against any party to the dispute.

#### CLINICAL HISTORY

This patient reported lumbar injury in the work place on \_\_\_. Specifics of this injury involve the sudden onset of low back and lower extremity pain during the lifting of copy paper. Conservative measures were employed initially, however the patient went on to have bilateral L5 decompressive laminectomy with posterior lumbar interbody fusion at L5/S1 on 12/06/01. Recurrent back pain suggested to be facet mediated has prompted consideration of bilateral L3/4, L4/5 and L5/S1 facet injections.

#### REQUESTED SERVICE

Bilateral lumbar facet injections x2 are requested for this patient.

#### DECISION

The reviewer agrees with the prior adverse determination.

#### BASIS FOR THE DECISION

Previous surgical intervention at L5/S1 likely precludes one's ability to effectively perform facet injections at that level. Further, there are no objective indicators in the materials reviewed regarding the efficacy of previous facet injections.

Additionally, the reviewer cannot recommend injection of neurolytics, if that is what is being proposed here (i.e. operative report 02/17/00 Re: Bilateral lumbar facet injections) based on the information provided for review.

### **YOUR RIGHT TO REQUEST A HEARING**

Either party to medical dispute may disagree with all or part of the decision and has a right to request a hearing.

**If disputing a spinal surgery prospective decision**, a request for a hearing must be in writing, and it must be received by the TWCC Chief Clerk of Proceedings within **10** (ten) calendar days of your receipt of this decision (28 Tex. Admin. Code 142.5(c)).

**If disputing other prospective medical necessity (preauthorization) decisions**, a request for a hearing must be in writing, and it must be received by the TWCC Chief Clerk of Proceedings within **20** (twenty) calendar days of your receipt of this decision (28 Tex. Admin. Code 142.5(c)).

This decision is deemed received by you 5 (five) days after it was mailed or the date of fax (28 Tex. Admin. Code 102.5(d)). A request for a hearing and a **copy of this decision** must be sent to:
