The independent review for the patient named above has been completed.

- Parker Healthcare Management received notification of independent review on 10.21.05.

- The reviewer rendered a determination on 12.2.05.

The findings of the independent review are as follows:

Questions for Review

Medical necessity of proposed discography at L3-4, L4-5, L5-S1 with post CT scan.

Determination

PHMO, Inc. has performed an independent review of the proposed care to determine if the adverse determination was appropriate. After review of all medical records received from both parties involved, the PHMO, Inc. physician reviewer has determined to **uphold the denial** on the requested service(s).

Summary of Clinical History

Mr. ____ sustained a work related job injury on ____, while employed with JC Penny Corp, Inc.

Clinical Rationale

This patient is 57 years of age and has diabetes mellitus and a polyneuropathy that is described as chronic and severe. He had a lumbar MRI on 5.31.05 that showed disc abnormalities at four levels. The use of discography is to allegedly locate the "pain generator" yet the patient's lumbar spine has only one normal level morphologically at L1-2 on the MRI. Any fusion surgery would be juxtaposed to a morphologically abnormal disc. Mr. ____'s facet disorder would preclude use of artificial disc replacement. Thus, the proposed procedure is not medically necessary in this patient even without any documented psychological analysis of his pain behavior.

Clinical Criteria, Utilization Guidelines or other material referenced

- Spine Instructional Course Lectures, 2003, American Academy Orthopedic Surgeons.

This conclusion is supported by the reviewers' clinical experience with over 15 years of patient care and orthopedic surgery.

The reviewer for this case is a Medical Doctor licensed by the Texas State Board of Medical Examiners. The reviewer is a diplomate of the American Board of Orthopedic Surgery, and is engaged in the full time practice of medicine.

The review was performed in accordance with Texas Insurance Code 21.58C and the rules of Texas Department of Insurance /Division of Workers' Compensation. In accordance with the act and the rules, the review is listed on the DWC's list of approved providers or has a temporary exemption. The review includes the determination and the clinical rationale to support the determination. Specific utilization review criteria or other treatment guidelines used in this review are referenced.

The reviewer signed a certification attesting that no known conflicts-of-interest exist between the reviewer and the treating and/or referring provider, the injured employee, the injured employee's employer, the injured employee's insurance carrier, the utilization review agent, or any of the treating doctors or insurance carrier health care providers who reviewed the case for decision before referral to the IRO. The reviewer also attests that the review was performed without any bias for or against the patient, carrier, or other parties associated with this case.

Your Right To Appeal

If you are unhappy with all or part of this decision, you have the right to appeal the decision. The decision of the Independent Review Organization is binding during the appeal process.

If you are disputing the decision (other than a spinal surgery prospective decision), the appeal must be made directly to a district court in Travis County (see Texas Labor Code §413.031). An appeal to District Court must be filed not later than 30 days after the date on which the decision that is the subject of the appeal is final and appealable.

If you are disputing a spinal surgery prospective decision, a request for a hearing must be in writing and it must be received by the Division of Workers' Compensation, Chief Clerk of Proceedings, within ten (10) days of your receipt of this decision.
