RATIONALE/BASIS FOR DECISION

This chronic pain interdisciplinary program is well suited to the chronic pain syndrome patient. The literature to support such a program can be found in Dr. Aronoff's *Principles and Practice of Pain Management*; Dr. Deyo, JAMA 250:1057-1062, 1083; Drs. Fordyce and King numerous pivotal peer reviewed references. Upon review of this literature, it is clear that there exists positive and current peer reviewed literature for chronic pain interdisciplinary programs.

An appeal to District Court must be filed not later than 30 days after the date on which the decision that is the subject of the appeal is final and appealable. If you are disputing a spinal surgery prospective decision, a request for a hearing must be in writing and it must be received by the Division of Workers' Compensation, Chief Clerk of Proceedings, within ten (10) days of your receipt of this decision.
