**Evidence of Declination:**

- Map For structures located in Harris County, include a map showing the exact location of the structure.
- Replacement Cost Estimate For each building structure to be covered a current Replacement Cost Valuation for both residential and commercial structures is required, using the TWIA Marshall & Swift/Boeckh (MSB) Replacement Cost calculator accessed on the TWIA web site. FAILURE TO DO SO WILL RESULT IN THE APPLICATION BEING RETURNED UNPROCESSED.
