**National Council on Compensation Insurance *Item 01-TX-2019***

**Description:**

- The National Council on Compensation Insurance (NCCI) filed *Item 01-TX-2019 Revisions to Basic Manual for Workers Compensation and Employers Liability Insurance and Forms Manual of Workers Compensation and Employers Liability Insurance in Texas* on November 12, 2019.
- This filing:
  - eliminates references to relativities in ratemaking;
  - revises the rate basis for payroll for Code 0923—Domestic Workers—Residences—Payroll Basis;
  - revises the references to the premium basis for limousines and taxicabs;
  - revises the email address for the submission of applications for Group Purchase of Workers Compensation Insurance and adds a space for Group Number on the GPP-2A application form; and
  - eliminates the applicability of the Nonratable Element rule in its entirety.

**Requested Effective Date:**

- The filing proposes that the changes in *Item 01-TX-2019* apply to new and renewal workers' compensation policies effective on and after July 1, 2020.

**Affected NCCI Manuals:**

- *Basic Manual for Workers Compensation and Employers Liability Insurance*; and
- *Forms Manual of Workers Compensation and Employers Liability Insurance*.
