General remarks and official action taken:

The subject of this order is whether disciplinary action should be taken against Markaye Blake.

FINDINGS OF FACT

1. Markaye Blake, individual identification number 1979058, holds a non-resident general lines agent license with a property and casualty qualification, originally issued by TDI on February 10, 2015.
2. On November 7, 2017, the department sent a notice of hearing to Blake's last known address provided in writing to the department, 113 Sugar Creek Lane, Troutman, North Carolina 28166.
3. Blake failed to file a written response to the notice of hearing within 20 days of the date the notice of hearing was mailed.
4. Blake has a non-resident license because she lives in North Carolina. This license type requires that Blake have a resident license in good standing in her home state.
5. On January 10, 2017, the North Carolina Department of Insurance revoked Blake's resident insurance agent license. Blake did not notify TDI of the revocation.
6. Delaware, Louisiana, and South Carolina also took administrative action against Blake. Blake did not notify TDI of those administrative actions.

CONCLUSIONS OF LAW

1. The commissioner of insurance has jurisdiction over this matter pursuant to TEX. INS. CODE §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, 4051.051, and 4056.052, and TEX. GOV'T CODE §§ 2001.051- 2001.178.
2. TEX. GOV'T CODE § 2001.056; TEX. INS. CODE § 82.055; and 28 TEX. ADMIN. CODE §§ 1.47, 1.88, and 1.89 give the commissioner authority to dispose of this case informally.
3. Based on 28 TEX. ADMIN. CODE § 19.906, Blake's last known address is presumed to be 113 Sugar Creek Lane, Troutman, North Carolina 28166.
4. TDI sent a notice of hearing to Blake's last known address, as required by 28 TEX. ADMIN. CODE §§ 1.28(d) and 1.88(c), 1 TEX. ADMIN. CODE § 155.401, and TEX. GOV'T CODE Ch. 2001.
5. The allegations in the notice of hearing, set out herein as findings of fact nos. 1 and 4-6, are deemed admitted as true pursuant to 28 TEX. ADMIN. CODE § 1.89.
6. Blake does not hold a license in good standing as an agent in her state of residence, as required by TEX. INS. CODE § 4056.052, and is no longer eligible to hold a non-resident license in Texas.
7. Blake failed to notify the department of the administrative actions taken against her, in violation of TEX. INS. CODE § 4001.252.

It is ordered that Markaye Blake's non-resident general lines agent license with a property and casualty qualification is revoked.

- c. First class and certified letters, return receipts requested containing a notice of hearing, were sent to Blake’s last known address.




