General remarks and official action taken:

The subject of this order is whether disciplinary action should be taken against Todd Jeremy Fendler.

FINDINGS OF FACT

1. Todd Jeremy Fendler, individual identification number 1383760, holds a non-resident general lines agent license with a property and casualty qualification, originally issued by TDI on August 8, 2014.
2. On November 6, 2017, the department sent a notice of hearing to Fendler's last known address provided in writing to the department, 1231 National Ave., Rockford, Illinois 61103-7139, and one additional address: 6090 Strathmoor Dr., Ste. 3, Rockford, Illinois 61107-5200.
3. Fendler failed to file a written response to the notice of hearing within 20 days of the date the notice of hearing was mailed.
4. Fendler has a non-resident license because he lives in Illinois. This license type requires that Fendler have a resident license in good standing in his home state.
5. On November 30, 2016, Fendler's resident insurance license expired, and Fendler failed to renew the license.
6. Fendler does not hold an active license in his home state.
7. Kansas, Louisiana, Missouri, and South Carolina also took administrative action against Fendler. Fendler did not notify TDI of those administrative actions.

CONCLUSIONS OF LAW

1. The commissioner of insurance has jurisdiction over this matter pursuant to TEX. INS. CODE §§ 82.051-82.055, 4001.002, 4001.252, 4005.101, 4005.102, 4051.051, and 4056.052, and TEX. GOV'T CODE §§ 2001.051-2001.178.
2. TEX. GOV'T CODE § 2001.056; TEX. INS. CODE § 82.055; and 28 TEX. ADMIN. CODE §§ 1.47, 1.88, and 1.89 give the commissioner authority to dispose of this case informally.
3. Based on 28 TEX. ADMIN. CODE § 19.906, Fendler's last known address is presumed to be 1231 National Ave., Rockford, Illinois 61103-7139.
4. The department sent a notice of hearing to Fendler's last known address, as required by 28 TEX. ADMIN. CODE §§ 1.28(c) and 1.88(c), 1 TEX. ADMIN. CODE § 155.401, and TEX. GOV'T CODE Ch. 2001. The department also sent a notice of hearing to one additional address: 6090 Strathmoor Dr., Ste. 3, Rockford, Illinois 61107-5200.
5. The department's allegations in the notice of hearing, set out herein as findings of fact nos. 1 and 4-7, are deemed admitted as true pursuant to 28 TEX. ADMIN. CODE § 1.89.
6. Fendler does not hold a license in good standing as an agent in his state of residence, as required by TEX. INS. CODE § 4056.052, and is no longer eligible to hold a non-resident license in Texas.
7. Fendler did not notify the department of the administrative actions taken against him, in violation of TEX. INS. CODE § 4001.252.

It is ordered that Todd Jeremy Fendler's non-resident general lines agent license with a property and casualty qualification is revoked.
