 MULTIPLE FIXED PANEL STORE FRONT ASSEMBLY WITH 90° AND/OR 135° CORNERS**

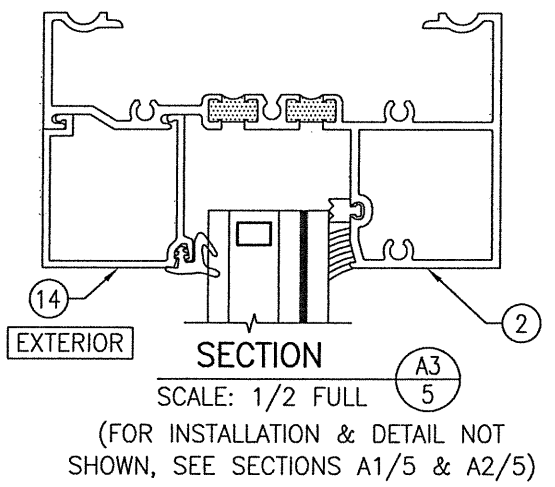
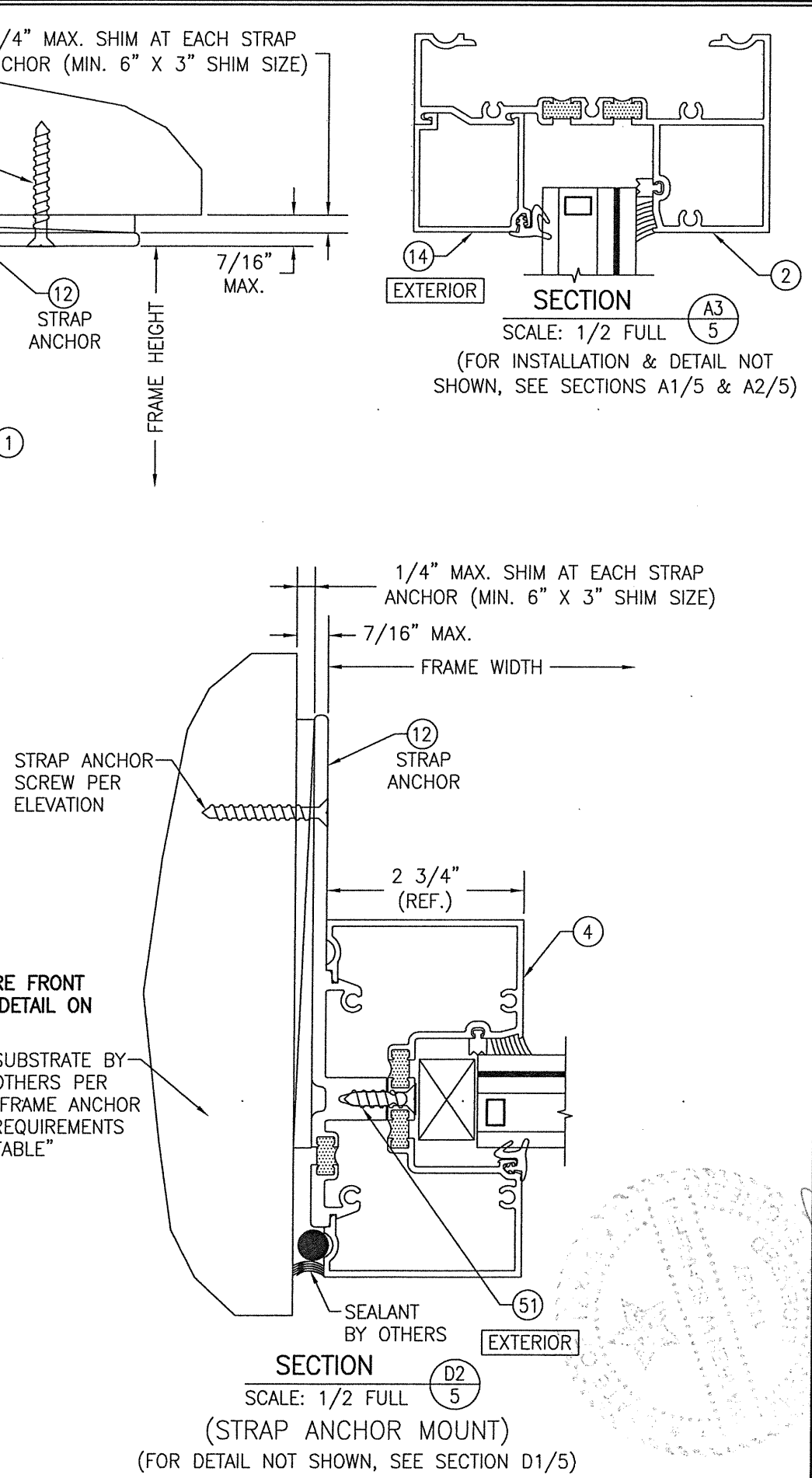
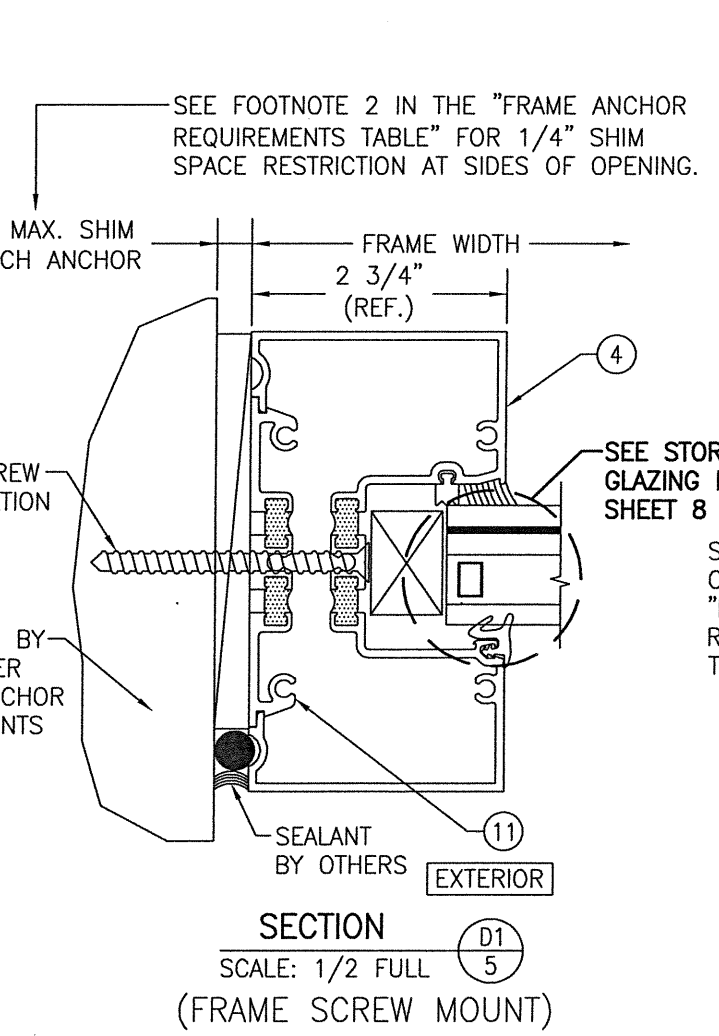
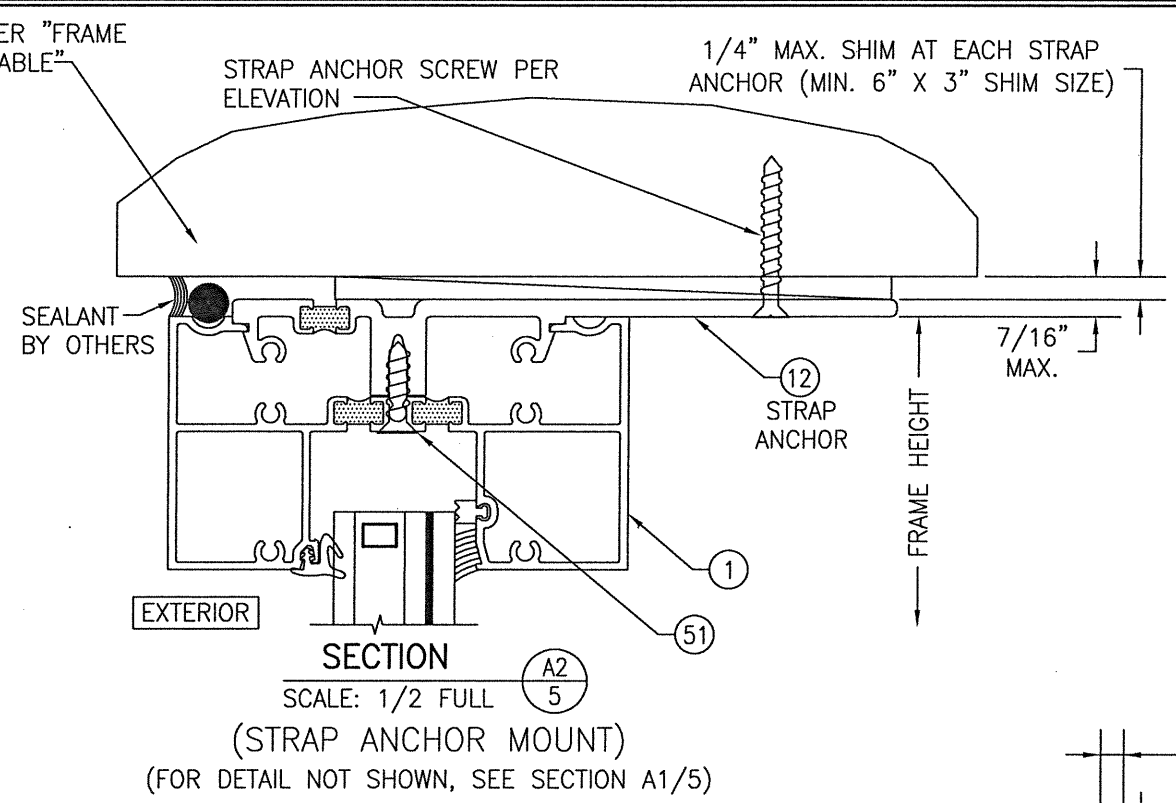
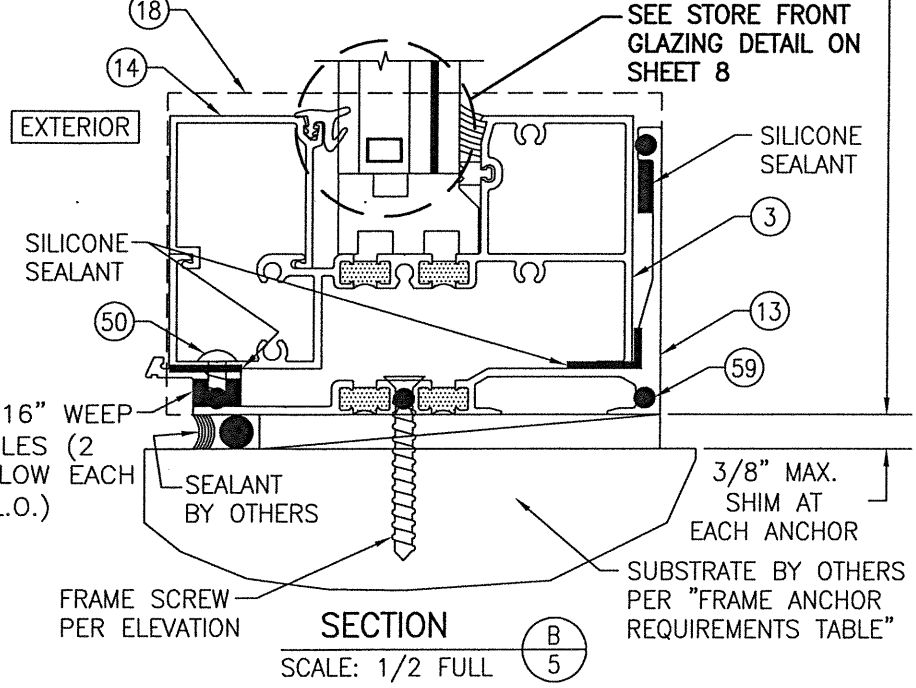
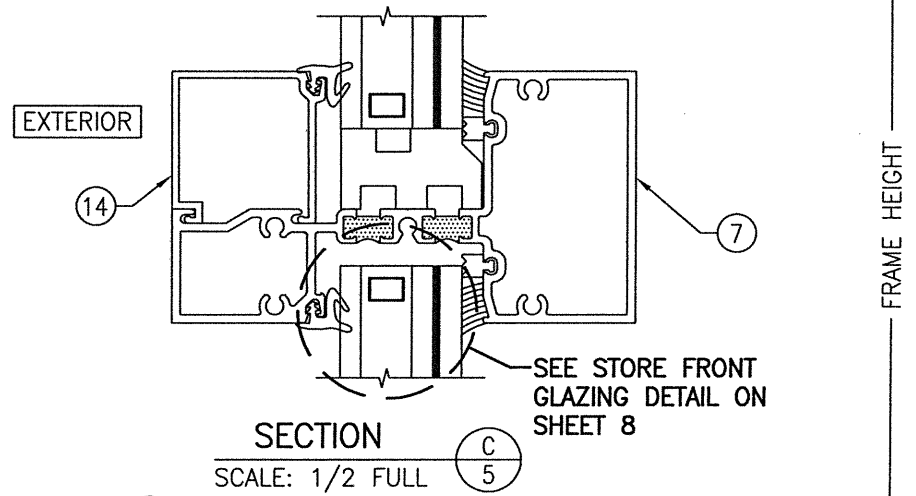
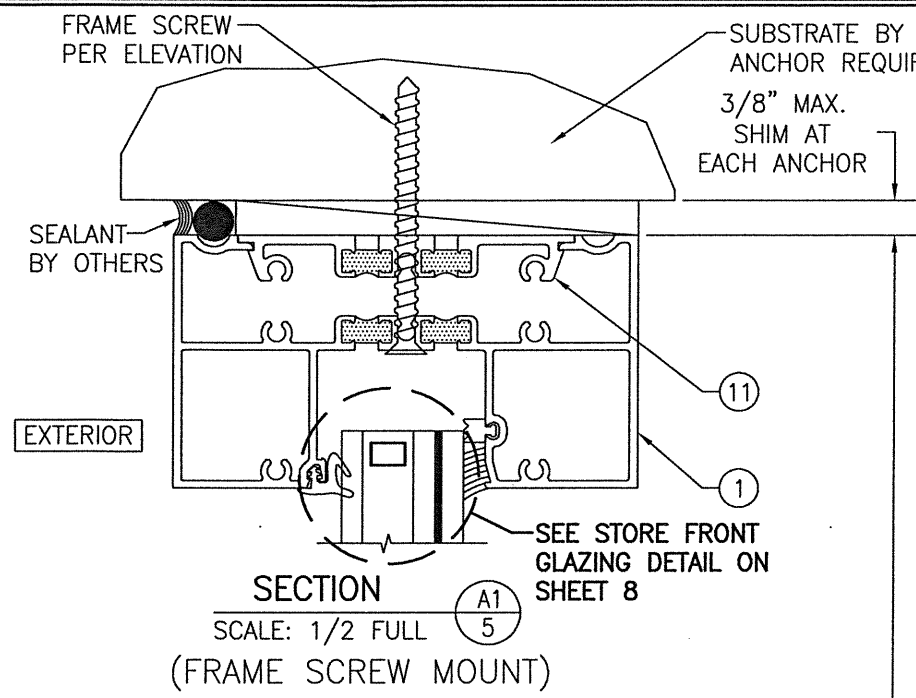
