

How to view and print a Certificate of Compliance



- 1. Visit tdi.texas.gov/wind
- 2. In the Topics A-Z section, click Windstorm System
- 3. Click the Find a Certificate icon
- 4. To search by application ID
 - a. Enter the application ID
 - b. Click search by application
- 5. To search by address
 - a. Enter at least the first two street numbers
 - b. Enter at least three characters in the street name
 - c. Enter city, Zip Code, or County
 - d. Click search by address

Note: This system does <u>not</u> require wildcards such as %

Windstorm System Features and Benefits

Entering WPI-1

- Reduce errors with drop down lists.
- Match addresses with addresses that already have Certificates of Compliance or use address standardizer to match TWIA applications.
- System checks prevent submission without all required information.
- Comments are collected in an organized, easy to manage fashion.
- Reduce the time required to complete forms with templates containing all required contact information for commonly used builders or contractors.
- Receive an application ID immediately upon submission.
- Ability to copy all data for a similar application, great for use with two structures at the same address (house and detached garage) or when inspecting several houses on the same block (a new housing development or after a large storm).
- Data entered is immediately included in Windstorm system; no waiting for staff to enter.

Application Details/Corrections

- Ability to search for applications to avoid duplicate submissions.
- Faster notification of necessary corrections.
- Easy to make and submit changes or corrections, without printing and faxing another WPI-1.
- Simple and quick way to exchange comments intake staff regarding changes or corrections to the application.
- Constant access to managing and reprinting forms such as the WPI-1, WPI-2, and WPI-8.
- Ability to manage and oversee all files you are currently inspecting and track application status changes.

Entering WPI-2

- Address, inspection type and detail, and comments are transferred from the WPI-1 to the WPI-2 automatically, reducing time and the possibility of errors.
- System checks prevent submission without all required information.

Profile

- Ability to update contact information and inspection preferences and have changes immediately reflected on the website.
- Ability to list all the counties you work in.
- Ability to manage subordinates and give your staff access to enter data into the system on your behalf, but remove the subordinates if their employment status changes.
