**CONSENT ORDER**  
TDI ENFORCEMENT FILE NO. 5294

**General remarks and official action taken:**

The commissioner of insurance considers whether disciplinary action should be taken against Kenrick Demione Gage.

**Waiver**

Gage acknowledges that the Texas Insurance Code and other applicable law provide certain rights relating to the subject matter of any disciplinary proceeding and how it is conducted. Gage waives all of these rights in consideration of the entry of this consent order.

**Findings of Fact**

1. Gage, individual identification no. 1091773, holds a public insurance adjuster license issued by the Texas Department of Insurance on February 14, 2012.
2. Gage performed the acts of a public insurance adjuster through the corporation Gage Adjusting Group, LLC (GAG) before GAG obtained a separate public insurance adjuster license.
3. On April 11, 2014, TDI sent written notice to Gage that GAG needed a corporate public insurance adjuster license.
4. On October 2, 2014, TDI received an application from Gage to obtain a public insurance adjuster license for GAG. The application could not be processed because GAG had forfeited its existence with the Texas Secretary of State on February 8, 2013, and GAG did not provide proof of financial responsibility.

5. GAG's existence with the Texas Secretary of State was reinstated on January 21, 2015, and GAG also provided proof of financial responsibility. TDI granted GAG public insurance adjuster license no. 2002072 on May 13, 2015.

### Conclusions of Law

1. The commissioner has jurisdiction over this matter pursuant to TEX. INS. CODE chs. 82, 84, 4005, and 4102; and TEX. GOV'T CODE §§ 2001.051-2001.178.
2. The commissioner has the authority to dispose of this case informally pursuant to TEX. GOV'T CODE § 2001.056; TEX. INS. CODE §§ 36.104 and 82.055; and 28 TEX. ADMIN. CODE § 1.47.
3. Gage violated TEX. INS. CODE §§ 4102.051, 4102.055, and 4102.162; and 28 TEX. ADMIN. CODE § 19.704.


The commissioner orders Kenrick Demione Gage to pay a \$500 administrative penalty within 30 days from the date of this order. The administrative penalty must be paid by cashier's check or money order made payable to the "State of Texas." 
