General remarks and official action taken:

The commissioner of insurance considers the application for a general lines agent license with a life, accident, and health qualification for Quiante Camille Martin.

FINDINGS OF FACT

The commissioner makes the following findings of fact:

1. On July 8, 2015, Quiante Camille Martin submitted an application for a general lines agent license with a life, accident, and health qualification.
2. On September 11, 2015, the department proposed to deny Martin's application based on her criminal history. She appealed that decision and made a written request for a hearing.
3. On January 31, 2017, the department sent a notice of hearing to Martin's last known address provided in writing to the department, 225 S Boon Avenue, Tyler, Texas 75702.
4. Martin failed to file a written response to the notice of hearing within 20 days of the date the notice of hearing was mailed.
5. On August 30, 2000, Martin pleaded guilty to the offense of Theft by Check >=\$20 <\$500, a class B misdemeanor, in Cause Number 001-84184-00 in the County Court at Law of Smith County, Texas. The court imposed a sentence of 180 days probation, 50 hours community service, court costs of \$140.25, restitution in the amount of \$1,197.11, and other fees in the amount of \$315.00. The court revoked her probation on April 20, 2001, for failing to meet the conditions of probation and sentenced her to five days incarceration.

6. On November 2, 2004, Martin pleaded guilty to the offense of Theft by Check \geq \$20 $<$ \$500, a class B misdemeanor, in Cause Number 002-85018-04 in the County Court at Law No 2 of Smith County, Texas. The court imposed a sentence of 180 days incarceration, six months' probation, 80 hours of community service, court costs of \$186.00, restitution in the amount of \$140.50, fines in the amount of \$180.00 and other fees in the amount of \$347.00. The court revoked her probation on June 14, 2005, for failing to meet the conditions of probation and sentenced her to three days incarceration.
7. On July 17, 2009, Martin pleaded guilty to the offense of theft by check $<$ \$1,500.00 with two or more previous convictions, a state jail felony, in Cause Number 241-0460-09 in the 241st District Court of Smith County, Texas. The court imposed a sentence of three years deferred adjudication, court costs of \$330.00, restitution in the amount of \$151.66 and other fees in the amount of \$3,199.00. The court revoked her probation on March 2, 2013, for failing to meet the conditions of probation and sentenced her to 45 days incarceration.

CONCLUSIONS OF LAW

The commissioner makes the following conclusions of law:

1. The commissioner of insurance has jurisdiction over this matter pursuant to TEX. INS. CODE §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, and 4054.051; TEX. GOV'T CODE §§ 2001.051- 2001.178; 28 TEX. ADMIN. CODE § 1.502; and TEX. OCC. CODE §§ 53.021-53.023.
2. TEX. GOV'T CODE § 2001.056; TEX. INS. CODE § 82.055; and 28 TEX. ADMIN. CODE §§ 1.47, 1.88, and 1.89 give the commissioner authority to dispose of this case informally.
3. Based on 28 TEX. ADMIN. CODE § 19.906, Martin's last known address is presumed to be 225 S Boon Avenue, Tyler, Texas 75702.
4. TDI sent a notice of hearing to Martin's last known address, as required by 28 TEX. ADMIN. CODE §§ 1.28(c) and 1.88(c), 1 TEX. ADMIN. CODE § 155.401, and TEX. GOV'T CODE Ch. 2001.
5. The allegations in the notice of hearing, set out herein as findings of fact nos. 1-2 and 5-7, are deemed admitted as true pursuant to 28 TEX. ADMIN. CODE § 1.89.
6. Martin committed an act for which the department may deny a license pursuant to TEX. INS. CODE ANN. § 4005.101(b).
7. Martin committed an offense that the department considers to be of such serious nature that it is of prime importance in determining fitness for licensure or authorization, as contemplated by 28 TEX. ADMIN. CODE § 1.502(e).
8. Martin committed an offense for which fraud, dishonesty, or deceit is an essential element, as contemplated by 28 TEX. ADMIN. CODE § 1.502(e)(1).
9. Martin was convicted of a felony, as contemplated by TEX. INS. CODE § 4005.101(b)(8).



10. Martin committed a felony or misdemeanor that directly relates to the business of insurance, as contemplated in 28 TEX. ADMIN. CODE § 1.502(d) and TEX. OCC. CODE § 53.021-53.023.
11. Martin was convicted of a felony involving dishonesty or breach of trust, as specified in 18 U.S.C §1033 and requiring written consent from the commissioner of insurance to engage or participate in the business of insurance.

The commissioner of insurance denies Quiante Camille Martin's application for a general lines agent license with a life, accident, and health qualification.

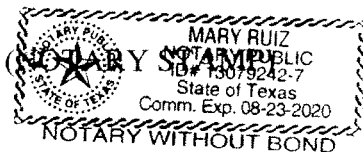
