**General remarks and official action taken:**

The subject of this order is whether disciplinary action should be taken against Evan Salomon.

**FINDINGS OF FACT**

1. Evan Salomon, individual identification number 1437462, holds a non-resident general lines agent license with a life, accident, and health qualification, originally issued by TDI on February 20, 2015.
2. On November 6, 2017, the department sent an amended notice of hearing to Salomon's last known address provided in writing to the department, 2075 Warrensville Center Rd., No. 4, South Euclid, Ohio 44121, and one additional address: 2 Summit Place Park Dr., No. 500, Independence, Ohio 44131.
3. Salomon failed to file a written response to the amended notice of hearing within 20 days of the date the notice of hearing was mailed.
4. Salomon has a non-resident license because he lives in Ohio. This license type requires that Salomon have a resident license in good standing in his home state.
5. On July 19, 2016, the Ohio Department of Insurance revoked Salomon's resident insurance agent license. Salomon did not notify TDI of the revocation.

**CONCLUSIONS OF LAW**

1. The commissioner of insurance has jurisdiction over this matter pursuant to TEX. INS. CODE §§ 82.051-82.055, 4001.002, 4001.252, 4005.101, 4005.102, 4054.051, and 4056.052, and TEX. GOV'T CODE §§ 2001.051-2001.178.

2. TEX. GOV'T CODE § 2001.056; TEX. INS. CODE § 82.055; and 28 TEX. ADMIN. CODE §§ 1.47, 1.88, and 1.89 give the commissioner authority to dispose of this case informally.
3. Based on 28 TEX. ADMIN. CODE § 19.906, Salomon's last known address is presumed to be 2075 Warrensville Center Rd., No. 4, South Euclid, Ohio 44121.
4. The department sent an amended notice of hearing to Salomon's last known address, as required by 28 TEX. ADMIN. CODE §§ 1.28(c) and 1.88(c), 1 TEX. ADMIN. CODE § 155.401, and TEX. GOV'T CODE Ch. 2001. The department also sent an amended notice of hearing to one additional address: 2 Summit Place Park Dr., No. 500, Independence, Ohio 44131.
5. The department's allegations in the amended notice of hearing, set out herein as findings of fact nos. 1 and 4-5, are deemed admitted as true pursuant to 28 TEX. ADMIN. CODE § 1.89.
6. Salomon does not hold a license in good standing as an agent in his state of residence, as required by TEX. INS. CODE § 4056.052, and is no longer eligible to hold a non-resident license in Texas.
7. Salomon did not notify the department of the administrative action taken against him, in violation of TEX. INS. CODE § 4001.252.

It is ordered that Evan Salomon's non-resident general lines agent license with a life, accident, and health qualification is revoked.






