**General remarks and official action taken:**

The subject of this order is whether disciplinary action should be taken against Solomon Eric Bowens.

**WAIVER**

Bowens acknowledges that the Texas Insurance Code and other applicable laws provide certain rights. Bowens waives all of these rights in consideration of the entry of this consent order.

**FINDINGS OF FACT**

**Licensing History**

1. Solomon Eric Bowens, individual identification no. 302366, holds a general lines agent license with a property and casualty qualification, and a life, accident, and health qualification, originally issued by the Texas Department of Insurance on November 11, 2000.
2. Bowens also holds a public insurance adjuster license, originally issued by the department on January 2, 2013.

**Use of Unregistered Name**

3. In August of 2015, the department received a complaint alleging Bowens had used a name that had not been registered with the department in several instances in his public insurance adjuster contract.

- 4. When Bowens issued the contracts, he maintained an individual public insurance adjuster license. Bowens has applied for a public insurance adjuster license for the entity BA Public Adjusters, LLC to come into compliance.
- 5. Bowens has cooperated fully with the department's investigation and agrees to continue complying with all insurance laws in the future.

**CONCLUSIONS OF LAW**

- 1. The commissioner of insurance has jurisdiction over this matter pursuant to TEX. INS. CODE §§ 82.001-82.056, 84.021-84.022, 4005.101, 4005.102, and 4102.051, and TEX. GOV'T CODE §§ 2001.051-2001.178.
- 2. The commissioner of insurance has the authority to dispose of this case informally pursuant to the provisions of TEX. GOV'T CODE § 2001.056, TEX. INS. CODE §§ 36.104 and 82.055, and 28 TEX. ADMIN. CODE § 1.47.
- 3. Bowens willfully violated an insurance law of this state, in violation of TEX. INS. CODE § 4005.101(b)(1), as contemplated by TEX. INS. CODE § 4005.102.
- 4. Bowens violated TEX. INS. CODE § 4102.051 by operating as a public insurance adjuster firm without a license.

It is ordered that Solomon Eric Bowens pay a \$1,000 administrative penalty within 60 days from the date of this order. The administrative penalty must be paid by cashier's check or money order made payable to the "State of Texas." Mail the administrative penalty to the Texas Department of Insurance, Attn: Enforcement Section, Division 60851, MC 9999, P.O. Box 149104, Austin, Texas 78714-9104.

It is ordered that a public insurance adjuster license is granted to BA Public Adjusters, LLC.
