General remarks and official action taken:

The subject of this order is whether disciplinary action should be taken against Jordan Tyrone Bolin Branch (Bolin Branch). A copy of this order will be provided to law enforcement and/or other appropriate administrative agencies for further investigation as may be warranted.

FINDINGS OF FACT

Licensure

1. Bolin Branch, individual identification no. 1413028, holds a general lines agent license with a life, accident, and health qualification originally issued by the Texas Department of Insurance on December 3, 2014.

Agent Misconduct

2. American Family Life Assurance Company of Columbus (AFLAC) appointed Bolin Branch as an insurance agent.
3. From approximately January 1, 2016, through March 11, 2016, Bolin Branch created and submitted fictitious AFLAC payroll policies. Bolin Branch submitted five fraudulent group policy applications and 222 fraudulent individual policy applications for groups and individuals who either did not exist or did not purchase these AFLAC policies.
4. Bolin Branch received \$38,666.00 in unearned commissions for these fictitious policies.

5. The department sent Bolin Branch a written request for information pursuant to TEX. INS. CODE § 38.001 on October 3, 2017. Bolin Branch did not respond to the department's request.

Failure to Respond to Notice of Hearing


6. On December 5, 2017, the department sent a notice of hearing to Bolin Branch's last known address provided in writing to the department, 2231 Live Oak Street, Apt. 2499, Commerce, Texas 75428.
7. Bolin Branch failed to file a written response to the notice of hearing within 20 days of the date the notice of hearing was mailed.

CONCLUSIONS OF LAW

1. The commissioner has jurisdiction over this matter pursuant to TEX. INS. CODE §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, and 4054.051, and TEX. GOV'T CODE §§ 2001.051-2001.178.
2. TEX. GOV'T CODE § 2001.056; TEX. INS. CODE § 82.055; and 28 TEX. ADMIN. CODE §§ 1.47, 1.88, and 1.89 give the commissioner authority to dispose of this case informally.
3. Based on 28 TEX. ADMIN. CODE § 19.906, Bolin Branch's last known address is presumed to be 2231 Live Oak Street, Apt. 2499, Commerce, Texas 75428.
4. The department sent a notice of hearing to Bolin Branch's last known address, as required by 28 TEX. ADMIN. CODE §§ 1.28(c) and 1.88(c), 1 TEX. ADMIN. CODE § 155.401, and TEX. GOV'T CODE Ch. 2001.
5. The department's allegations in the notice of hearing, set out herein as findings of fact nos. 1-5, are deemed admitted as true pursuant to 28 TEX. ADMIN. CODE § 1.89.
6. Bolin Branch has committed acts for which a license holder may be disciplined under TEX. INS. CODE § 4005.101, as contemplated by TEX. INS. CODE § 4005.102.
7. Bolin Branch has willfully violated an insurance law of this state, pursuant to TEX. INS. CODE § 4005.101(b)(1).
8. Bolin Branch misappropriated, converted to his own use, or illegally withheld money belonging to an insurer, insured, or beneficiary, in violation of TEX. INS. CODE § 4005.101(b)(4).
9. Bolin Branch engaged in fraudulent or dishonest acts or practices, in violation of TEX. INS. CODE § 4005.101(b)(5).

10. Bolin Branch failed to timely respond to a request for information sent pursuant to TEX. INS. CODE § 38.001.

It is ordered that Jordan Tyrone Bolin Branch's general lines agent license with a life, accident, and health qualification is revoked.


