### General remarks and official action taken:

This is a default order taken against Daniel Ochoa (Ochoa) and Ochoa Insurance Services, LLC (Ochoa Insurance) because Ochoa and Ochoa Insurance engaged in fraudulent or dishonest acts or practices, Ochoa failed to respond to a department inquiry, and Ochoa Insurance engaged in acts constituting the business of insurance without a license. Ochoa and Ochoa Insurance did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order revokes Ochoa's license and orders Ochoa Insurance to cease and desist from engaging in the unauthorized business of insurance.

The following findings of fact and conclusions of law are adopted:

**Findings of Fact** 

Failure to Respond to Notice of Hearing

- 1. On February 25, 2020, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.
- 3. The department sent the Notice of Hearing and Original Petition to Ochoa's last known address provided in writing to the department, Texas 79938. The Notice of Hearing and Original Petition were also sent to one additional address associated with Ochoa and Ochoa Insurance:

  , El Paso, Texas 79935.
- 4. Ochoa and Ochoa Insurance failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

### **Conclusions of Law**

- 1. The commissioner of insurance has jurisdiction over this matter pursuant to Tex. Ins. Code §§ 82.051-82.055, 84.021-84.022, 101.102, 4001.002, 4001.101, 4005.101, 4005.102, 4051.051, and 4054.051, and Tex. Gov't Code §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally pursuant to Tex. Gov't Code § 2001.056; Tex. Ins. Code § 82.055; and 28 Tex. Admin. Code §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing pursuant to Tex. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 Tex. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Ochoa and Ochoa Insurance's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default pursuant to 28 Tex. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true pursuant to 28 Tex. Admin. Code § 1.89.

### Order

It is ordered that Daniel Ochoa's general lines agent license with a life, accident, and health, and property and casualty qualification is revoked. It is also ordered that Ochoa Insurance Services, LLC, cease and desist from engaging in the unauthorized business of insurance. A copy of this order will be provided to law enforcement and/or other appropriate administrative agencies for further investigation as may be warranted.

### ORIGINAL PETITION

The Texas Department of Insurance seeks to take disciplinary action against Daniel Ochoa and Ochoa Insurance Services, LLC. (collectively, Respondents). In support of this petition, the department makes the following allegations upon information and belief:

### Jurisdiction

The commissioner of insurance has jurisdiction over this matter pursuant to Tex. INS. CODE §§ 82.051-82.055, 84.021-84.022, 101.102, 4001.002, 4001.101, 4005.101, 4005.102, 4051.051, 4054.051, and Tex. Gov't Code §§ 2001.051-2001.178.

### **Factual Allegations**

# Licensure and Background

- 1. Daniel Ochoa (Ochoa), individual identification no. 1201561, holds a general lines agent license with a life, accident, and health qualification, and a property and casualty qualification, originally issued by Texas Department of Insurance on May 3, 2013.
- 2. Ochoa Insurance Services, LLC (Ochoa Insurance), firm identification no. 147038, holds a general lines agency license with a property and casualty qualification, originally issued by the department on August 23, 2018.

3. Farmers Insurance Companies (Farmers) appointed Ochoa as an agent from May 2013, through February 2018.

### Fraudulent/Dishonest Conduct

- 4. In August 31, 2017, Farmers' Internal Audit received an underwriting referral for Ochoa due to his low underwriting quality index score. Farmers' Underwriting noted the possible manipulation of 16 roofing permits to support a new roof discount. The roof permit documentation submitted by the agency did not match the documentation on the city of El Paso building permit website. In addition, Farmers' Underwriting identified 19 questionable proof of prior insurance documents submitted by Ochoa's agency. As a result, Farmers' Internal Audit opened an investigation on the Ochoa's agency.
- 5. On September 22, 2017, Farmers conducted an interview with Ochoa and two of his employees, Mary Monje (Monje) and Marleen Roth (Roth). Monje was the only other licensed agent at Ochoa's agency. Roth was not licensed and was responsible for daily, routine office work which included scanning documents to Farmers' Imaging Center. Monje's license expired January 31, 2020.
- 6. During the interview on September 22, 2017, Roth admitted to creating all of the fictitious documents that were discovered during the audit one month prior. Roth said she created these documents when she was unable to obtain the necessary documents from the insureds. Both Ochoa and Monje signed written statements during the interview admitting they were unaware that the documents were fraudulent, but both Ochoa and Monje acknowledged that the activity had occurred at the agency.
- 7. Ochoa's written statement collected during the interview also acknowledged some of the fictitious documents were used on policies he personally wrote.
- 8. The very next day, after the interview was concluded, Roth emailed the Farmers district manager and said Ochoa and Monje had pressured her to take the blame for the fraudulent documents. Roth stated that she had never forged any documents while working at the agency and that her statements to the Farmers' investigator the day before were not true.

9. Farmers subsequently informed the department that its investigation had found that Ochoa and Ochoa Insurance had engaged in fraudulently manipulating proof of prior insurance documents and roof certificates in order to place coverage with Farmers or to earn discounted premiums.

# **Unlicensed Agency**

10. Ochoa operated Ochoa Insurance without holding an agency license for approximately two and a half years—from February of 2016 until August 23, 2018, when the agency was licensed by the department.

### Failure to Timely Respond to Requests for Information

11. On September 28, 2018, the department sent Ochoa a request for information pursuant to Tex. INS. Code § 38.001 which required Ochoa to respond in writing not later than the 15th day after Ochoa received the request. Ochoa requested an extension, which the department granted, but the department never received a response from Ochoa.

# **Legal Allegations**

- 1. Respondents have committed acts for which a license holder may be disciplined under Tex. Ins. Code § 4005.101, as contemplated by Tex. Ins. Code §§ 4005.102 and 4101.201.
- 2. Respondents have willfully violated an insurance law of this state, pursuant to TEX. INS. CODE § 4005.101(b)(1).
- 3. Respondents have engaged in fraudulent or dishonest acts or practices, in violation of Tex. Ins. Code § 4005.101(b)(5).
- 4. Ochoa failed to respond to a department inquiry in writing not later than the 15th day after the date he received the inquiry, in violation of Tex. INS. CODE § 38.001.
- 5. Respondents have engaged in acts constituting the business of insurance without a license as defined in Tex. Ins. Code §§ 101.102, 4001.101, and 4051.051.

# **Relief Sought**

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. revoking Ochoa and Ochoa Insurance's licenses;
- 2. assessing an administrative penalty;
- 3. ordering restitution paid; and
- 4. any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.
