General remarks and official action taken:

This is a default order taken against Porfirio Tapia (Respondent) because he misappropriated premiums and converted them to his own use and engaged in fraudulent or dishonest acts and practices. Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order revokes Respondent's license.

The following findings of fact and conclusions of law are adopted:

Findings of Fact

Failure to Respond to Notice of Hearing

- 1. On July 8, 2020, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.
- 3. The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department, for t

> Christi, Texas 78467. The Notice of Hearing and Original Petition were also sent by electronic mail and to two additional addresses associated with Respondent: , Corpus Christi, Texas 78404, and Corpus Christi, Texas 78404, and Corpus Christi, Texas 78404.

4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

Conclusions of Law

- 1. The commissioner has jurisdiction pursuant to Texas law, including TEX. INS. CODE §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, 4051.051, 4054.051 and 4101.051; and TEX. Gov'T CODE §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally pursuant to TEX. GOV'T CODE § 2001.056; TEX. INS. CODE § 82.055; and 28 TEX. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing pursuant to TEX. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 TEX. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default pursuant to 28 TEX. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true pursuant to 28 TEX. ADMIN. CODE § 1.89.

Order

It is ordered that Porfirio Tapia's general lines agent license with a life, accident, and health qualification and a general lines agent license with a property and casualty qualification, and his adjuster license with a property and casualty qualification are revoked. A copy of this order will be provided to law enforcement and/or other appropriate administrative agencies for further investigation as may be warranted.



ORIGINAL PETITION

The Texas Department of Insurance seeks to take disciplinary action against Porfirio Tapia. In support of this petition, the department makes the following allegations upon information and belief:

Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter pursuant to TEX. INS. CODE §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, 4051.051, 4054.051 and 4101.051, and TEX. GOV'T CODE §§ 2001.051-2001.178.

Factual Allegations

- Porfirio Tapia (Tapia), individual identification no. 388164, holds a general lines agent license with a life, accident, and health qualification and a property and casualty qualification issued by the Texas Department of Insurance on September 4, 1985. Tapia also holds an adjuster license with a property and casualty qualification.
- 2. Tapia is doing the business of insurance with a registered name of Tapia Insurance Agency.
- Tapia has engaged in a pattern of misconduct that has led to multiple insureds having lapses in insurance coverage with Texas Windstorm Insurance Association (TWIA) resulting in uncovered losses.

- 4. Tapia received a premium payment of \$698 from consumer R.M. on April 4, 2017 for renewal of his TWIA policy #xxxxx792-01.
- 5. Tapia failed to timely forward the renewal premium and the policy expired on May 9, 2017.
- 6. On September 13, 2017, Tapia submitted a new application and the premium to renew R.M.'s policy #xxxxx792-01. TWIA issued policy #xxxxx792-02 in replacement with an effective date of September 15, 2017.
- 7. The delay in providing payment to renew the windstorm coverage resulted in a lapse of coverage between May 9 and September 15, 2017, during which time R.M. incurred an uncovered loss from Hurricane Harvey. The damages have not been paid for or repaired.
- 8. Tapia received a premium payment of \$1,000 from consumer J.M.'s mortgage company on May 8, 2017, for renewal of her TWIA policy #xxxxx916-01.
- 9. Tapia failed to timely forward the renewal premium and the policy expired on June 10, 2017.
- 10. On August 31, 2017, Tapia submitted a new application and the premium to renew J.M.'s policy #xxxxx916-01. TWIA issued policy # xxxxx916-02 in replacement with an effective date of September 7, 2017.
- 11. The delay in providing payment to renew the windstorm coverage resulted in a lapse of coverage between June 10 and September 7, 2017, during which time R.M. incurred an uncovered loss from Hurricane Harvey. The damages have not been paid for or repaired.
- 12. Tapia received a premium payment of \$1,200 from consumer B.D. on June 12, 2017 for renewal of his TWIA policy #xxxxx440-01.
- 13. Tapia failed to timely forward the renewal premium and the policy expired on June 21, 2017.

- 14. On November 9, 2017, Tapia submitted a new application and \$929 in premium to renew B.D.'s policy #xxxxx440-01. TWIA issued policy #xxxxx440-02 in replacement with an effective date of November 9, 2017.
- 15. The delay in providing payment to renew the windstorm coverage resulted in a lapse of coverage between June 21 and November 9, 2017, during which time B.D. incurred an uncovered loss from Hurricane Harvey. Tapia's errors and omissions insurance paid for B.D.'s damages.

Legal Allegations

- 1. Tapia committed acts for which a license holder may be disciplined under TEX. INS. CODE § 4005.101, as contemplated in TEX. INS. CODE § 4005.102.
- Tapia willfully violated an insurance law of this state, as contemplated by TEX. INS. CODE § 4005.101(b)(1).
- Tapia misappropriated, converted to his own use, or illegally withheld money belonging to an insured or insurer, as contemplated by TEX. INS. CODE § 4005.101(b)(4).
- 4. Tapia engaged in fraudulent or dishonest acts or practices, in violation of TEX. INS. CODE § 4005.101(b)(5).

Relief Sought

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. revoking Porfirio Tapia's licenses and
- 2. any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.


