General remarks and official action taken:

This is a default order taken against Kacey Adam Toliver (Respondent) because he created and presented fictitious certificates of insurance to consumers and misappropriated premiums converting them to his own use. Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order revokes Respondent's license.

The following findings of fact and conclusions of law are adopted:

Findings of Fact

Failure to Respond to Notice of Hearing

- 1. On July 1, 2020, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.

- 3. The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department, Texas 79536-6102. The Notice of Hearing and Original Petition were also sent by electronic mail.
- 4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

Conclusions of Law

- 1. The commissioner has jurisdiction pursuant to Texas law, including Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4001.102, 4001.105, 4005.101-4005.105, and 4054.051; Tex. Occ. Code §§ 53.021-53.023; 28 Tex. Admin. Code § 1.502; and Tex. Gov't Code §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally pursuant to Tex. Gov't Code § 2001.056; Tex. Ins. Code § 82.055; and 28 Tex. Admin. Code §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing pursuant to Tex. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 Tex. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default pursuant to 28 Tex. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true pursuant to 28 Tex. Admin. Code § 1.89.

Order

It is ordered that Kacey Adam Toliver's general lines license with life, accident, health, and HMO qualification is revoked. A copy of this order will be provided to law enforcement and/or other appropriate administrative agencies for further investigation as may be warranted.

ORIGINAL PETITION

The Texas Department of Insurance seeks to take disciplinary action against Kacey Adam Toliver. In support of this petition, the Department makes the following allegations upon information and belief:

Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter pursuant to Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, and 4054.051, and Tex. Gov't Code §§ 2001.051-2001.178.

Factual Allegations

- Kacey Adam Toliver (Toliver), individual identification number 1519997, holds a general lines license with life, accident, health, and HMO qualification, issued by the Department on August 22, 2008.
- Toliver created and presented a fictitious certificate of insurance to consumer, P.O.
 In doing so he purported to be an agent for Texas Wasatch Insurance Services LP,
 an operating entity of Goosehead Insurance.
- 3. Toliver accepted insurance premiums in the amount of \$700 from consumer, P.O., for the fraudulent policy and failed to submit an application for policy.

- 4. Toliver created and presented a fictitious certificate of insurance to Black Diamond Landscaping. In doing so he purported to be an agent for Texas Wasatch Insurance Services LP, an operating entity of Goosehead Insurance.
- 5. Toliver accepted insurance premiums in the amount of \$700 from Black Diamond Landscaping for the fraudulent policy and failed to submit an application for policy.
- 6. Toliver is not and has not ever been authorized to act as an agent for Texas Wasatch Insurance Services LP or Goosehead Insurance.
- 7. Toliver was sent an inquiry pursuant to Tex. INS. Code § 38.001 on December 2, 2019, and failed to respond in writing not later than the 15th day after the date the inquiry was received.

Legal Allegations

- 1. Toliver has committed acts for which a license holder may be disciplined under TEX. INS. CODE § 4005.101, as contemplated in TEX. INS. CODE § 4005.102.
- 2. Toliver has misappropriated or converted for his own use money belonging to an insured or insurer, as contemplated by Tex. INS. CODE § 4005.101(b)(4).
- 3. Toliver has engaged in fraudulent or dishonest acts or practices, as contemplated by Tex. Ins. Code § 4005.101(b)(5).
- 4. Toliver solicited a contract for insurance or acted as an agent without having been appointed by an authorized insurance company in violation of Tex. INS. CODE § 4001.201.
- 5. Toliver failed to respond to a written inquiry pursuant to Tex. INS. CODE § 38.001.

Relief Sought

If one or more of the above allegations is found to be true, the Department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. revoking Kacey Adam Toliver's license and
- 2. any other just and appropriate relief to which the department may be entitled to by law.
