General remarks and official action taken:

This is a default order taken against Fortino Rene Rivera (Respondent) because Respondent does not hold a license in good standing as an agent in his home state of residence making him no longer eligible to hold a nonresident license in Texas and Respondent did not notify the Texas Department of Insurance (TDI) of administrative actions taken against him. Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order revokes Respondent's license.

The following findings of fact and conclusions of law are adopted:

Findings of Fact

Failure to Respond to Notice of Hearing

- 1. On July 15, 2020, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.

- 3. The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department, Irvine, CA 92612. The Notice of Hearing and Original Petition were also sent by electronic mail.
- 4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

Conclusions of Law

- 1. The commissioner has jurisdiction pursuant to Texas law, including Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, and 4054.301, and TEX. GOV'T CODE §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally pursuant to Tex. GOV'T CODE § 2001.056; Tex. Ins. CODE § 82.055; and 28 Tex. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing pursuant to Tex. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 Tex. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default pursuant to 28 Tex. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true pursuant to 28 Tex. Admin. Code § 1.89.



ORIGINAL PETITION

The Texas Department of Insurance seeks to take disciplinary action against Fortino Rene Rivera. In support of this petition, the department makes the following allegations upon information and belief:

Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter pursuant to Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, and 4054.301, and Tex. Gov't Code §§ 2001.051-2001.178.

Factual Allegations

- 1. Fortino Rene Rivera (Rivera), individual identification number 2171991, holds a non-resident life agent license, originally issued by the Texas Department of Insurance (TDI) on March 15, 2017.
- 2. Rivera has a Texas non-resident license because he lives in California. This license type requires that Rivera have a resident license in good standing in his home state.
- 3. In July 2019, FINRA took administrative action against Rivera, CRD number 6358600. Specifically, Rivera consented to FINRA barring him from acting as a broker or otherwise associating with a broker-dealer firm. Rivera did not notify TDI of that administrative action.

4. On February 7, 2020, the California Department of Insurance revoked Rivera's resident insurance agent license as a result of being barred by FINRA. Rivera did not notify TDI of the revocation.

Legal Allegations

- 1. Rivera does not hold a license in good standing as an agent in his home state of residence, as required by Tex. INS. CODE § 4056.052, and is no longer eligible to hold a non-resident license in Texas.
- 2. Rivera did not notify TDI of the administrative actions taken against him, in violation of Tex. INS. CODE § 4001.252.

Relief Sought

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. revoking Rivera's license and
- 2. any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.
