#### General remarks and official action taken:

The subject of this default order is whether a general lines license with property and casualty qualification should be issued to Chyrele L. Ferris (Respondent). Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order denies Respondent's license application.

The following findings of fact and conclusions of law are adopted:

#### **Findings of Fact**

#### Failure to Respond to Notice of Hearing

- 1. On July 31, 2020, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.
- 3. The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department,

, Lancaster, Texas 75134-3176. The Notice of Hearing and Original Petition were also sent by electronic mail to Respondent.

4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

#### **Conclusions of Law**

- 1. The commissioner has jurisdiction pursuant to Texas law, including TEX. INS. CODE §§ 82.051-82.055, 4001.002, 4001.102, 4001.105, 4005.101-4005.105, 4051.051 and 4101.051; TEX. OCC. CODE §§ 53.021-53.023; 28 TEX. ADMIN. CODE § 1.502; and TEX. GOV'T CODE §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally pursuant to TEX. GOV'T CODE § 2001.056; TEX. INS. CODE § 82.055; and 28 TEX. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing pursuant to TEX. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 TEX. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default pursuant to 28 TEX. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true pursuant to 28 TEX. ADMIN. CODE § 1.89.



# **ORIGINAL PETITION**

The Texas Department of Insurance seeks to deny Chyrele L. Ferris' license application. In support of this petition, the Department makes the following allegations upon information and belief:

#### Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter pursuant to TEX. INS. CODE §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, and 4051.051; TEX. GOV'T CODE §§ 2001.051-2001.178; 28 TEX. ADMIN. CODE §§ 1.502; and TEX. Occ. CODE §§ 53.021 - 53.023.

#### **Factual Allegations**

Licensing Application

- 1. Chyrele L. Ferris (Ferris) submitted an application for a general lines license with a property and casualty qualification to the department on May 24, 2018.
- 2. The department proposed to deny Ferris' license on July 26, 2018, based on her criminal history. The department received Ferris' request for a hearing on August 17, 2018.

#### Criminal History

- 3. On June 7, 2002, Ferris pled guilty to Motor Vehicle theft in Aurora Municipal Court in Case number J05851 and was placed on probation. On December 12, 2002, defendant was sentenced to 15 days of jail.
- 4. On April 17, 2003, Ferris pled guilty to Assault and sentenced to 30 days jail, concurrent with an unknown Denver County sentence, in the District Court of Adams County, Colorado, in cause/case no. 2002JD000912.
- 5. On May 5, 2011, Ferris pled guilty to Assault and was sentenced to two years probation in County Court of Arapahoe County in case number 2010M001731.
- 6. On March 3, 2014, Ferris pled guilty to Criminal Impersonation and Forgery. She received 2 years deferred adjudication probation on ct. 2, Criminal Impersonation, and 2 years straight probation on count 3, Forgery, in District Court, Douglas County, Colorado in case number CR000490.
- 7. On April 1, 2014, Ferris pled guilty to ct. 3, Assault, in cause no. 2010M001731 in County Court, Arapaho County, Colorado.

#### Legal Allegations

- 8. Ferris committed offenses that the department considers to be of such a serious nature that they are of prime importance in determining fitness for licensure, as contemplated by 28 TEX. ADMIN. CODE § 1.502(e)(4)(B), (G), and (J).
- 9. Department guidelines, 28 TEX. ADMIN. CODE § 1.502(c)-(e), emphasize that TDI:
  - a. considers it very important that applicants be honest, trustworthy, and reliable;
  - b. may refuse to issue an original license if the department determines that the applicant has committed a felony or misdemeanor that directly relates to the duties and responsibilities of the licensed occupation; and

c. considers Ferris' criminal offenses and pattern of behavior to be of such a serious nature that they are of prime importance when determining fitness for licensure. 28 TEX. ADMIN. CODE § 1.502(e)(4)(B), (G), and (J).

#### **Relief Sought**

If one or more of the above allegations is found to be true, the Department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order denying Ferris' license application and any other just and appropriate relief to which the Department may be entitled to by law, including any combination of the above actions.
