General remarks and official action taken:

This is a default order taken against Javier Herrera (Respondent) because he engaged in fraudulent and dishonest practices, engaged in unauthorized insurance, failed to respond to official inquiries, and failed to register an assumed name with the Texas Department of Insurance. Respondent did not respond to a Notice of Hearing filed by the department. This order revokes Respondent's license.

The following findings of fact and conclusions of law are adopted:

Findings of Fact

Failure to Respond to Notice of Hearing

- On July 29, 2020, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.

- 3. The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department, San Antonio, Texas 78221-2328. The Notice of Hearing and Original Petition were also sent by electronic mail and to the email address associated with Respondent.
- 4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

Conclusions of Law

- 1. The commissioner has jurisdiction pursuant to Texas law, including Tex. Ins. Code §§ 82.051-82.055, 84.021-82.044, 4001.002, 4005.101, 4005.102, and 4051.101, and Tex. Gov't Code §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally pursuant to Tex. GOV'T CODE § 2001.056; Tex. Ins. CODE § 82.055; and 28 Tex. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing pursuant to Tex. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 Tex. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default pursuant to 28 Tex. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true pursuant to 28 Tex. Admin. Code § 1.89.

ORIGINAL PETITION

The Texas Department of Insurance seeks to take disciplinary action against Javier Herrera (Herrera), Respondent. In support of this petition, the department makes the following allegations upon information and belief:

Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter pursuant to Tex. Ins. Code §§ 82.051-82.055, 84.021-82.044, 4001.002, 4005.101, 4005.102, and 4051.101, and Tex. Gov't Code §§ 2001.051-2001.178.

Factual Allegations

Licensure and Background

1. Herrera, individual identification number 1338092, holds a limited lines agent license originally issued by the Texas Department of Insurance on February 2, 2017.

Fake Documents

2. A consumer filed a complaint with the department because she believed that three of her used car dealership's customers' insurance cards seemed very questionable. Complainant called the insurance company and was told they had no insureds with those names and the policy numbers were not for any of their insurance policy numbers. The customers of the complainant claimed that Herrera issued the fake insurance cards.

<u>Unauthorized Business of Insurance</u>

- 3. An employee of Herrera admitted she was not licensed but was authorized by Herrera to use his license while he was on vacation. One or more employees of Herrera, who also were not licensed agents, were offering insurance quotes on Facebook.
- 4. Herrera has three locations selling insurance under the assumed name Cowboy Insurance. Cowboy Insurance is not a licensed agency and the name is not registered as an assumed name with the department.

Failure to Respond to Department Inquiries

5. On January 8, 2020 and January 30, 2020, requests for information pursuant to TEX. INS. CODE § 38.001 were sent to Herrera, and he failed to respond to the inquiries.

Legal Allegations

- 1. Herrera committed acts for which a license holder may be disciplined under TEX. INS. CODE § 4005.101, as contemplated by TEX. INS. CODE § 4005.102.
- 2. Herrera willfully violated an insurance law of this state, as contemplated by TEX. INS. CODE § 4005.101(b)(1).
- 3. Herrera misappropriated, converted to his own use, or illegally withheld money belonging to an insurer, HMO, insured, enrollee or beneficiary, as contemplated by Tex. Ins. Code § 4005.101(b)(4).
- 4. Herrera engaged in fraudulent or dishonest acts or practices, Tex. INS. CODE § 4005.101(b)(5).
- 5. Herrera engaged in unauthorized insurance by allowing his employees to act as insurance agents when they were not licensed agents, in violation of Tex. INS. CODE §§ 101.051 and 4051.101.
- 6. Herrera violated Tex. Admin. Code § 19.902 and/or Tex. Ins. Code §§ 101.051 because Cowboy Insurance is not licensed or registered as an assumed name with the department.

Relief Sought

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. revoking respondent's license,
- 2. directing respondent to pay an administrative penalty under Tex. INS. CODE §§ 84.021 84.022,
- 3. directing respondents to make restitution to victims under Tex. INS. CODE § 82.053, and
- 4. any other just and appropriate relief to which the Department may be entitled to by law, including any combination of the above actions.
