General remarks and official action taken:

This is a default order taken against Merlon D. Watson and M D Watson Insurance Agency, LLC (Respondents) because Merlon D. Watson provided fictitious bonds and certificates of insurance to consumers and misappropriated premiums and converted them to his own use. Respondents did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order revokes Respondents' licenses.

The following findings of fact and conclusions of law are adopted:

Findings of Fact

Failure to Respond to Notice of Hearing

- 1. On July 15, 2020, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.

- 3. The department sent the Notice of Hearing and Original Petition to Respondents' last known address provided in writing to the department, Houston, TX 77096. The Notice of Hearing and Original Petition were also sent by electronic mail to Respondents.
- 4. Respondents failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

Conclusions of Law

- 1. The commissioner has jurisdiction pursuant to Texas law, including TEX. INS. CODE §§ 82.051-82.055, 4001.002, 4001.102, 4001.105, 4005.101-4005.105, 4101.051 and 4054.051; TEX. OCC. CODE §§ 53.021-53.023; 28 TEX. ADMIN. CODE § 1.502; and TEX. GOV'T CODE §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally pursuant to TEX. GOV'T CODE § 2001.056; TEX. INS. CODE § 82.055; and 28 TEX. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing pursuant to TEX. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 TEX. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondents' failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default pursuant to 28 TEX. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true pursuant to 28 TEX. ADMIN. CODE § 1.89.

ORIGINAL PETITION

The Texas Department of Insurance seeks to take disciplinary action against Merlon D. Watson and M D Watson Insurance Agency, LLC. In support of this petition, the department makes the following allegations upon information and belief:

Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter pursuant to TEX. INS. CODE §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, and 4051.051. 4054.051, and TEX. GOV'T CODE §§ 2001.051-2001.178.

Factual Allegations

- 1. Merlon D. Watson (Watson), individual identification number 762712, holds a general lines license with property and casualty qualification issued by the Department on June 1, 1990, and a life, accident, health, and HMO qualification issued by the Department on November 9, 1990.
- 2. M D Watson Insurance Agency, LLC, agency identification number 2256455, has held a general lines agency license with property and casualty qualification and life, accident, health, and HMO qualification issued by the Department on January 2, 2018.



- 3. Watson is the only designated responsible agent for M D Watson Insurance Agency, LLC.
- 4. Watson provided a fictitious certificate of insurance to A Status Construction for a Pollution Liability Policy by Hallmark Specialty Insurance.
- 5. Watson provided a fictitious certificate of insurance to A Status Construction for an Excess Liability policy by Acceptance Indemnity Insurance.
- 6. Watson collected premiums for the pollution liability policy by Hallmark Specialty Insurance and failed to submit application and premium to Hallmark Specialty Insurance thereby misappropriating and converting the funds to his own use.
- 7. Watson collected premiums for the excess liability policy by Acceptance Indemnity Insurance Company and failed to submit application and premium to Acceptance Indemnity Insurance Company thereby misappropriating and converting the funds to his own use.
- 8. Watson provided a fictitious payment bond to A Status Construction naming Merchants National Bonding Inc. as the purported surety for a KIPP Texas Inc. construction project.
- 9. Watson provided a fictitious performance bond to A Status Construction naming Merchants National Bonding Inc. as the purported surety for a KIPP Texas Inc. construction project.
- 10. Watson provided a fictitious bid bond to A Status Construction naming Merchants National Bonding Inc. as the purported surety for a KIPP Texas Inc. construction project.
- 11. Watson provided a fictitious payment bond to A Status Construction naming Merchants National Bonding Inc. as the purported surety for a University of Houston System construction project.
- 12. Watson provided a fictitious performance bond to A Status Construction naming Merchants National Bonding Inc. as the purported surety for a University of Houston System construction project.

- 13. Watson provided a fictitious performance bond to A Status Construction naming Merchants National Bonding Inc. as the purported surety for a City of Bellaire, Texas water and wastewater improvement project.
- 14. Watson provided a fictitious payment bond to A Status Construction naming Merchants National Bonding Inc. as the purported surety for a City of Bellaire, Texas water and wastewater improvement project.
- 15. Watson provided a fictitious bid bond to A Status Construction naming Merchants National Bonding Inc. as the purported surety for a City of Bellaire, Texas drainage and sidewalk project at Spruce and N. Fifth.
- 16. Watson provided a fictitious performance bond to A Status Construction naming Merchants National Bonding Inc. as the purported surety for a City of Bellaire, Texas water and wastewater improvement drainage and sidewalk project at Spruce and N. Fifth.
- 17. Watson provided a fictitious payment bond to A Status Construction naming Merchants National Bonding Inc. as the purported surety for a City of Bellaire, Texas drainage and sidewalk project at Spruce and N. Fifth.
- 18. Watson provided a fictitious bid bond to A Status Construction naming Merchants National Bonding Inc. as the purported surety for a City of Bellaire, Texas drainage and sidewalk project at Maple and Bolivar.
- 19. Watson collected premiums of approximately \$82,000 for fictitious bonds naming Merchants National Bonding Inc. as the purported surety and misappropriated and converted them to his own use at Maple and Bolivar.
- 20. Watson did not have a valid appointment with Merchants National Bonding Inc. and therefore did not have authorization to issue the bonds listed above.

Legal Allegations

1. Watson has willfully violated an insurance law of this state as contemplated in TEX. INS. CODE § 4005.101(b)(1).

- 2. Watson misappropriated, converted to his own use or illegally withheld money belonging to an insurer, HMO, insured, enrollee, or beneficiary as contemplated by TEX. INS. CODE § 4005.101(b)(4).
- 3. Watson engaged in fraudulent or dishonest acts or practices, as contemplated by TEX. INS. CODE § 4005.101(b)(5).
- 4. Watson solicited a contract of insurance or acted as an agent without having been appointed by an authorized insurance company, as contemplated by TEX. INS. CODE § 4001.201.

Relief Sought

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. revoking Merlon D. Watson's license;
- 2. revoking the license for M D Watson Insurance Agency, LLC;
- 3. directing Merlon D. Watson and M D Watson Insurance Agency, LLC to make restitution to victim under TEX. INS. CODE § 82.053; and
- 4. any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.
