General remarks and official action taken:

This is a default order taken against Latisha Denise Acker (Respondent) because she misappropriated insurance premiums and engaged in fraudulent and dishonest practices. Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order revokes Respondent's licenses.

The following findings of fact and conclusions of law are adopted:

Findings of Fact

Failure to Respond to Notice of Hearing

- On February 14, 2020, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.
- 3. The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department,

, Houston, Texas 77090. The Notice of Hearing and Original Petition were also sent by electronic mail to Respondent's electronic mail address on file with the department, attached as Exhibit F.

4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

Failure to Appear at Prehearing Conference

- 5. On May 27, 2020, the SOAH Administrative Law Judge (ALJ) entered Order No. 2 scheduling a prehearing conference on July 11, 2020, to discuss converting the hearing on the merits on September 15, 2020, to a telephonic hearing.
- 6. On June 8, 2020, the SOAH ALJ entered Order No. 3 rescheduling the prehearing conference to June 17, 2020, at 10:00 a.m.
- 7. After receiving proper notice of the date, time, and location of the prehearing conference regarding the hearing on the merits, Respondent failed to appear for the prehearing conference on June 17, 2020, as shown in the record in SOAH Docket No. 454-20-2639.C, and attached as Exhibit C.

Conclusions of Law

- 1. The commissioner has jurisdiction pursuant to Texas law, including TEX. INS. CODE §§ 82.051-82.055, 4001.002, 4005.101, 4001.102, 4005.102, 4051.201, and 4054.051 and TEX. Gov'T CODE §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally pursuant to TEX. GOV'T CODE § 2001.056; TEX. INS. CODE § 82.055; and 28 TEX. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing pursuant to TEX. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 TEX. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.

- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default pursuant to 28 TEX. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true pursuant to 28 TEX. ADMIN. CODE § 1.89.

Order

It is ordered that any licenses held by Latisha Denise Acker are revoked. A copy of this order will be provided to law enforcement and/or other appropriate administrative agencies for further investigation as may be warranted.



The Texas Department of Insurance seeks to take disciplinary action against Latisha Denise Acker. In support of this petition, the department makes the following allegations upon information and belief:

Jurisdiction

The commissioner of insurance has jurisdiction over this matter pursuant to TEX. INS. CODE §§ 82.051-82.055, 84.021-84.044, 4001.002, 4005.101, 4005.102, 4051.201, and 4054.051, and TEX. Gov'T CODE §§ 2001.051-2001.178.

Factual Allegations

<u>Licensure</u>

- 1. Latisha Denise Acker (Acker), individual identification number 18745227, holds a general lines agent license with a life, accident, and health qualification, originally issued by TDI on May 15, 2018.
- 2. Acker was subsequently issued a county mutual agent license by TDI on May 22, 2018.

Agent Misconduct

- 3. On May 22, 2018, Reliable Life Insurance Company (Reliable), a Kemper Company, appointed Acker as an insurance agent.
- 4. On or about November 6, 2018, Acker was cancelled for cause by Reliable for conversion.
- 5. Acker fraudulently converted \$1,620.09 of customer premiums to her own personal use.
- 6. Reliable covered the missing payments and continued to provide coverage to the insureds.
- 7. Acker has failed to reimburse Reliable and still owes Reliable \$1,620.09.

Legal Allegations

- 1. Acker has committed acts for which a license holder may be disciplined under TEX. INS. CODE § 4005.101, as contemplated by TEX. INS. CODE § 4005.102.
- 2. Acker has willfully violated an insurance law of this state, in violation of TEX. INS. CODE § 4005.101(b)(1).
- 3. Acker has misappropriated, converted to her own use, or illegally withheld money belonging to an insured, insurer, or beneficiary, in violation of TEX. INS. CODE § 4005.101(b)(4).
- 4. Acker has engaged in fraudulent or dishonest acts or practices, in violation of TEX. INS. CODE § 4005.101(b)(5).

Relief Sought

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. revoking Acker's license;

- 3. directing Acker to make restitution of \$1,620.09 to Reliable; and
- 4. any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.

ORDER NO. 2 SCHEDULING PREHEARING CONFERENCE

By Order No. 1, the hearing on the merits in this case was reset to convene at **9 a.m. on** July 15, 2020, in person, at the State Office of Administrative Hearings. Order No. 1 indicated, however, that in the event continuing disruptive effects of COVID-19 later threatened the ability to hold this hearing on the merits in person, the Administrative Law Judge (ALJ) would schedule a telephonic prehearing conference to discuss the various options with the parties.

ORDER NO. 2

ORDER NO. 4 CONVERTING HEARING ON MERITS TO TELEPHONE

On June 17, 2020, beginning at 10 a.m., the Administrative Law Judge (ALJ) attempted to convene the telephonic prehearing conference prescribed by Orders No. 2 and 3. The purpose of this prehearing conference, as detailed in Order No. 2, was to address options for conducting the July 15, 2020, hearing on the merits by remote means, as the ongoing COVID-19 situation will not permit an in-person hearing to be held at that time. - <u>Witness Identification</u>. By July 10, 2020, the parties shall file a witness list with the names and phone numbers for the witnesses they intend to call to testify during the hearing.
- <u>Witness Preparation</u>. Prior to the hearing, the parties must provide to witnesses all documents necessary for their effective participation in the hearing. Parties should also speak to the witnesses they intend to call to testify and advise them to expect a call from an unfamiliar number, and explain that they may be prompted by an automated system to join the conference call through which the hearing is being conducted.


