#### General remarks and official action taken:

This is a default order taken against Yessica E. Ruiz (Respondent) because Respondent misappropriated, converted to her own use, or illegally withheld money belonging to an insured, insurer, or beneficiary, in violation of Tex. Ins. Code § 4005.101(b)(4). Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order revokes Respondent's licenses.


The following findings of fact and conclusions of law are adopted:

#### Findings of Fact

#### Failure to Respond to Notice of Hearing

- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.

4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

#### **Conclusions of Law**

- 1. The commissioner has jurisdiction pursuant to Texas law, including Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, 4054.051; Tex. Occ. Code §§ 53.021-53.023; 28 Tex. Admin. Code § 1.502; and Tex. Gov't Code §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally pursuant to Tex. GOV'T CODE § 2001.056; Tex. Ins. CODE § 82.055; and 28 Tex. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing pursuant to Tex. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 Tex. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default pursuant to 28 Tex. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true pursuant to 28 Tex. Admin. Code § 1.89.

You have the right to appear at this hearing and to be represented by an attorney.

Parties that are not represented by an attorney may obtain information regarding contested case hearings on the public website of the State Office of Administrative Hearings at www.soah.texas.gov, or in printed format upon request to SOAH.

#### ORIGINAL PETITION

The Texas Department of Insurance seeks to take disciplinary action against Yesica E. Ruiz (Ruiz). In support of this petition, the department makes the following allegations upon information and belief:

#### Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter pursuant to Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, and Tex. Gov'T Code §§ 2001.051-2001.178.

#### **Factual Allegations**

- 1. Ruiz holds a general lines agent license with a life, accident and health qualification, issued by the department on February 25, 2013, and a county mutual agent license issued by the department on March 29, 2019.
- 2. Ruiz was appointed by American National Insurance Company (ANIC) on March 29, 2016, through May 18, 2018.
- 3. An ANIC audit revealed that Ruiz collected over \$2,000 in cash premium payments from policyholders between August 2017 and May 2018, which Ruiz failed to remit to ANIC.
- 4. Ruiz's relationship with ANIC was terminated effective May 18, 2018.

- 5. On June 13, 2019, the department's complaints processing division sent a request for information to the last email of record provided by Ruiz, pursuant to Tex. Ins. Code § 38.001, which required a response in writing not later than the 15th day after receipt of the request. Ruiz failed to respond.
- 6. On February 5 and 10, 2020, the department's complaints processing division left messages for Ruiz at the last phone number of record provided by Ruiz. Ruiz failed to respond.
- 7. On June 10, 2020, the department sent Ruiz a request for information pursuant to Tex. Ins. Code § 38.001, which required a response in writing not later than the 15th day after receipt, via certified mail to the address Ruiz specified. The department received notification that delivery was made on June 15, 2020. Ruiz failed to respond.

#### **Legal Allegations**

- 1. Ruiz committed acts for which a license holder may be disciplined under Tex. INS. CODE § 4005.101, as contemplated by Tex. INS. CODE § 4005.102.
- 2. Ruiz willfully violated an insurance law of this state, pursuant to Tex. Ins. CODE § 4005.101(b)(1).
- 3. Ruiz misappropriated, converted to her own use, or illegally withheld money belonging to an insured, insurer, or beneficiary, in violation of Tex. INS. CODE § 4005.101(b)(4).
- 4. Ruiz engaged in fraudulent or dishonest acts or practices, in violation of Tex. INS. CODE § 4005.101(b)(5).
- 5. Ruiz failed to respond to a department inquiry in writing not later than the 15th day after the date the inquiry was received, in violation of Tex. INS. CODE § 38.001.

#### **Relief Sought**

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. revoking Ruiz's license and
- 2. imposing any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.


