General remarks and official action taken:

This is a default order taken against James Mark Hatcher (Respondent) because he submitted unauthorized and forged applications for insurance policies and he misappropriated money belonging to an insurer. Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order revokes Respondent's licenses.

The following findings of fact and conclusions of law are adopted:

Findings of Fact

Failure to Respond to Notice of Hearing

- 1. On September 11, 2020, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.

- 3. The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department, Dallas, Texas 75240-1121. The Notice of Hearing and Original Petition were also sent by electronic mail to the Respondent.
- 4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

Conclusions of Law

- 1. The commissioner has jurisdiction pursuant to Texas law, including Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4001.102, 4001.105, 4005.101-4005.105, 4051.051, 4054.051 and 4101.051; Tex. Occ. Code §§ 53.021-53.023; 28 Tex. Admin. Code § 1.502; and Tex. Gov't Code §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally pursuant to Tex. GOV'T CODE § 2001.056; Tex. Ins. CODE § 82.055; and 28 Tex. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing pursuant to Tex. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 Tex. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default pursuant to 28 Tex. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true pursuant to 28 Tex. Admin. Code § 1.89.

ORIGINAL PETITION

The Texas Department of Insurance seeks to take disciplinary action against James Mark Hatcher. In support of this petition, the department makes the following allegations upon information and belief:

Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter pursuant to Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, 4051.051 and 4054.051, and Tex. Gov'T Code §§ 2001.051-2001.178.

Factual Allegations

- 1. James Mark Hatcher (Hatcher), individual identification number 635802, holds a general lines license with life, accident, health, and HMO qualification and a property and casualty qualification, issued by the Department on May 4, 1992.
- 2. Hatcher submitted an unauthorized and forged application for group insurance policies to Kemper Benefits on behalf of La Clinica De La Raza, Inc.
- 3. Hatcher submitted an unauthorized and forged application for group insurance policies to Mutual of Omaha Insurance Company on behalf of La Clinica De La Raza, Inc.

- 4. Hatcher received \$4,044.41 in unearned advanced commissions from Kemper Benefits for the unauthorized policies submitted for La Clinica De La Raza, Inc. and failed to return them to Kemper Benefits.
- 5. Hatcher received \$7,500.00 in unearned advance payments from Mutual of Omaha Insurance Company for the unauthorized policies submitted for La Clinica Da La Raza, Inc. and failed to return them to Mutual of Omaha Insurance Company.

Legal Allegations

- 1. Hatcher has willfully violated an insurance law of this state as contemplated in Tex. INS. CODE § 4005.101(b)(1).
- 2. Hatcher misappropriated, converted to his own use or illegally withheld money belonging to an insurer, HMO, insured, enrollee, or beneficiary as contemplated by Tex. Ins. Code § 4005.101(b)(4).
- 3. Hatcher engaged in fraudulent or dishonest acts or practices, as contemplated by Tex. Ins. Code § 4005.101(b)(5).

Relief Sought

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. revoking Hatcher's license;
- 2. directing Hatcher to make restitution to the victim under Tex. Ins. Code § 82.053; and
- 3. any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.
