General remarks and official action taken:

This is a default order taken against Chandler Thomas Robinson (Respondent) because he misappropriated premium, engaged in fraudulent or dishonest acts or practices, is not actively engaged in soliciting or writing insurance for the public, and failed to respond to information requests. Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order revokes Respondent's license.

The following findings of fact and conclusions of law are adopted:

Findings of Fact

Failure to Respond to Notice of Hearing

- On September 29, 2020, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.

- 3. The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department, P.O. Box 2438, Cedar Hill, Texas 75106-2438. The Notice of Hearing and Original Petition were also sent by electronic mail and to three additional addresses associated with Respondent:

 "Cedar Hill, Texas 75104;
 "Weatherford, Texas 76088; and, P.O. Box 1009, Cedar Hill, Texas 75106.
- 4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

Conclusions of Law

- 1. The commissioner has jurisdiction pursuant to Texas law, including Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4005.101-4005.102, 4051.051, and 4054.051, and Tex. GOV'T Code §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally pursuant to Tex. GOV'T CODE § 2001.056; Tex. Ins. CODE § 82.055; and 28 Tex. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing pursuant to Tex. Gov't Code §§ 2001.051, 2001.052, and 2001.054, and 28 Tex. Admin. Code §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default pursuant to 28 Tex. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true pursuant to 28 Tex. Admin. Code § 1.89.

ORIGINAL PETITION

The Texas Department of Insurance seeks to take disciplinary action against Chandler Thomas Robinson. In support of this petition, the department makes the following allegations upon information and belief:

Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter pursuant to Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4005.101-4005.102, 4051.051, and 4054.051, and Tex. Gov'T Code §§ 2001.051-2001.178.

Factual Allegations

Licensing and Background

- 1. Under individual identification number 498818, Chandler Thomas Robinson (Robinson) holds a general lines agent license originally issued on June 19, 2002, with a property and casualty qualification. On April 1, 2005, Robinson was also issued a life, accident, health, and HMO qualification by the department. Both of these qualifications expired June 19, 2008, due to a failure to renew, but the license with both of these qualifications was reissued by the department on May 29, 2009.
- 2. On April 28, 2016, Robinson and his father, David Robinson, obtained a general lines agency license with a property and casualty qualification for the David Robinson Insurance Agency, LLC, (the David Robinson Agency), firm identification number 117019. Department records show David Robinson was the sole owner,

and Robinson and David Robinson were the only officers and designated licensed responsible persons for the David Robinson Agency.

- 3. On July 15, 2018, David Robinson passed away.
- 4. On February 28, 2020, the David Robinson Agency forfeited its legal status According to records of the Texas Secretary of State.
- 5. On April 28, 2020, the David Robinson Agency insurance license expired without renewal. The David Robinson Agency holds no active licenses with the department.

Misappropriation of Premium

- 6. Working by and through the David Robinson Agency, Robinson misappropriated or converted thousands of dollars in premiums for his own use from a long-time commercial client, Dunn Asphalt Paving (Dunn Asphalt).
- 7. From May 15, 2018, through May 15, 2019, Dunn Asphalt was insured by commercial automobile insurance policy number 73******016, issued by National Liability and Fire Insurance Company. Because Dunn Asphalt desired to renew this policy, it authorized Robinson to withdraw the premium payments from its account.
- 8. Robinson withdrew and collected two insurance premium payments from Dunn Asphalt's bank account, \$5,000 on May 21, 2019, and \$6,124 on July 18, 2019. Robinson kept these payments for his own use, and did not remit or forward them to the insurer.
- 9. On or about July 24, 2019, Robinson also collected an insurance premium check for \$1,761.90 from Dunn Asphalt. This check was intended to pay the premium to renew general liability insurance policy number 3A****98, issued to Dunn Asphalt through Evanston Insurance and USG Insurance Services, Inc.
 - a. Robinson kept this payment for his own use and did not remit or forward it to the insurers.
 - b. Robinson also failed to respond to the insurance company's renewal correspondence.

c. The policy was not renewed, leaving Dunn Asphalt with no insurance coverage.

Fraudulent and Dishonest Acts

- 10. Robinson also misrepresented to Dunn Asphalt that it had insurance coverage when it did not. Robinson provided Dunn Asphalt with a fake insurance identification card showing insurance policy number 73*****016-1, issued by National Liability and Fire Insurance Company, effective May 21, 2019, through May 21, 2020. In fact, no such policy ever existed.
 - a. Robinson failed to timely accept the insurance company's renewal offer, so policy number 73******016 expired, leaving Dunn Asphalt uninsured.
 - b. Upon receipt of Robinson's untimely acceptance, the insurance company issued a new policy with a new effective date and a different policy number, 73*****999, to Dunn Asphalt.
 - c. Robinson, however, never sent payment to the insurance company for that new policy, so policy number 73*****999 was cancelled for non-payment on August 14, 2019, again leaving Dunn Asphalt uninsured.

Not Actively Soliciting or Writing Insurance

11. Robinson has no active appointments, and therefore is not actively engaged in soliciting or writing insurance for the public in Texas.

Failed to Respond to Information Requests

12. On June 10, 2020, and on June 29, 2020, the department sent Robinson written requests for information pursuant to Tex. Ins. Code § 38.001. Responses to those requests were due not later than 15 days after receipt. To date, he has failed to respond to both requests.

Legal Allegations

1. Robinson has committed acts for which a license holder may be disciplined under Tex. INS. CODE §§ 4005.101 and 4005.102.

- 2. Robinson willfully violated an insurance law of this state, in violation of Tex. INS. CODE § 4005.101(b)(1).
- 3. Robinson misappropriated, converted to his own use, or illegally withheld money belonging to an insurer, insured, or beneficiary, in violation of Tex. INS. CODE § 4005.101(b)(4).
- 4. Robinson engaged in fraudulent or dishonest acts or practices, in violation of Tex. Ins. Code § 4005.101(b)(5).
- 5. Robinson is not actively engaged in soliciting or writing insurance for the public generally as required by Tex. Ins. Code § 4001.104(a), in violation of Tex. Ins. Code § 4005.101(b)(10).
- 6. Robinson failed to timely respond to requests for information sent by the department pursuant to Tex. Ins. Code § 38.001.

Relief Sought

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. revoking Robinson's license;
- 2. directing Robinson to pay \$12,885.90 in restitution to Dunn Asphalt Paving; and
- 3. imposing any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.




