General remarks and official action taken:

This is a default order taken against Serge Tindong (Respondent) because he no longer holds a license in good standing in his state of residence and is no longer eligible to hold a non-resident license in Texas, engaged in fraudulent and dishonest practices, willfully violated an insurance law of this state, failed to notify the Texas Department of Insurance of an administrative action taken against him by an insurance regulator of another state, and is not actively engaged in soliciting or writing insurance for the public. Respondent did not respond to a Notice of Hearing filed by the department. This order revokes Respondent's license.

The following findings of fact and conclusions of law are adopted:

Findings of Fact

Failure to Respond to Notice of Hearing

 On September 24, 2020, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.

- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.
- 3. The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department, Rockville, Maryland 20852. The Notice of Hearing and Original Petition were also sent by electronic mail.
- 4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

Conclusions of Law

- 1. The commissioner has jurisdiction pursuant to Texas law, including Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4005.101-4005.102, 4054.301, and 4056.052, and Tex. GOV'T Code §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally pursuant to TEX. GOV'T CODE § 2001.056; TEX. INS. CODE § 82.055; and 28 TEX. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing pursuant to Tex. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 Tex. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default pursuant to 28 Tex. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true pursuant to 28 Tex. Admin. Code § 1.89.

ORIGINAL PETITION

The Texas Department of Insurance (TDI) seeks to take disciplinary action against Serge Tindong. In support of this petition, TDI makes the following allegations upon information and belief:

Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter pursuant to Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, and 4054.301, 4056.052, and Tex. Gov'T Code §§ 2001.051-2001.178.

Factual Allegations

Licensure

- 1. Serge Tindong (Tindong) holds a non-resident life agent license, originally issued by TDI on January 22, 2019.
- 2. Tindong has a Texas non-resident license because he lives in Maryland. This license type requires that Tindong have a resident license in good standing in his home state.

<u>Unreported Maryland Administrative Action and Lack of Appointments</u>

3. On May 1, 2020, the Maryland Insurance Commissioner (Maryland), issued an Order against Tindong in case no. MIA-2020-05-002. The Maryland Order:

- a. found that Tindong was terminated for cause by Mutual of Omaha Life Insurance Company on September 23, 2019, for alleged fraudulent actions—specifically an advanced commission scheme;
- b. revoked Tindong's Maryland resident insurance agent license; and
- c. assessed an administrative penalty of \$500 payable within 30 days of the date of the Maryland Order.
- 4. Tindong did not notify TDI of the revocation.
- 5. Tindong has no active appointments in Texas.

Legal Allegations

- 1. Tindong does not hold a license in good standing as an agent in his home state of residence, as required by Tex. INS. CODE § 4056.052, and is no longer eligible to hold a non-resident license in Texas.
- 2. Tindong has committed acts for which a license holder may be disciplined under Tex. Ins. Code §§ 4005.101 and 4005.102.
- 3. Tindong has willfully violated an insurance law of this state, in violation of Tex. INS. CODE § 4005.101(b)(1).
- 4. Tindong did not notify TDI of the administrative action(s) taken against him by an insurance regulator of another state, in violation of Tex. INS. CODE § 4001.252(a)(3).
- 5. Tindong engaged in fraudulent or dishonest acts or practices, in violation of TEX. INS. CODE § 4005.101(b)(5).
- 6. Tindong is not actively engaged in soliciting or writing insurance for the public generally as required by Tex. Ins. Code § 4001.104(a), in violation of Tex. Ins. Code § 4005.101(b)(10).

Relief Sought

If one or more of the above allegations is found to be true, TDI asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. revoking Tindong's license, and
- 2. imposing any other just and appropriate relief to which TDI may be entitled to by law, including any combination of the above actions.
