#### ORDER ON MOTION FOR REHEARING

#### General remarks and official action taken:

The subject of this order is the motion for rehearing filed by Carlyle T. Poindexter, Poindexter & Associates, Inc., and Surety One, Inc.

## **Background**

On October 8, 2020, Commissioner's Order No. 2020-6501 was issued. The Order included findings of fact and conclusions of law and ordered that the general lines agent licenses held by Carlyle T. Poindexter; Poindexter & Associates, Inc.; and Surety One, Inc. be revoked. The order was issued following a hearing on the merits of the proposed revocation of the licenses and the issuance of a proposal for decision by the presiding administrative law judge.

Counsel for Carlyle T. Poindexter; Poindexter & Associates, Inc.; and Surety One, Inc. submitted a motion for rehearing on October 30, 2020. On November 13, 2020, counsel for the Texas Department of Insurance submitted a reply to the motion for rehearing, and on November 14, 2020, counsel for Carlyle T. Poindexter; Poindexter & Associates, Inc.; and Surety One, Inc. submitted a reply to TDI's reply.

#### **Discussion**

Carlyle T. Poindexter; Poindexter & Associates, Inc.; and Surety One, Inc. have failed to demonstrate that a rehearing is warranted in this case. The motion for a rehearing largely rehashes arguments that were made to the administrative law judge. These arguments were sufficiently addressed by the administrative law judge. And because the administrative law judge's proposed findings of fact and conclusions of law were adopted in Commissioner's Order No. 2020-6501, no rehearing is necessary.

#### Order

It is ordered that the motion for rehearing filed by Carlyle T. Poindexter; Poindexter & Associates, Inc.; and Surety One, Inc. is denied.
