General remarks and official action taken:

This is a default order taken against Tanya Simmons Firmani (Respondent) because she does not hold a license in good standing as an agent in her home state of residence and she did not notify the Texas Department of Insurance of the administrative action taken against her. Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order revokes Respondent's license.

The following findings of fact and conclusions of law are adopted:

Findings of Fact

Failure to Respond to Notice of Hearing

- 1. On October 28, 2020, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.

- The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department, Hollywood, FL 33020. The Notice of Hearing and Original Petition were also sent by electronic mail.
- 4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

Conclusions of Law

- 1. The commissioner has jurisdiction pursuant to Texas law, including TEX. INS. CODE §§ 82.051-82.055, 4001.002, 4001.252, 4005.101, 4005.102, 4054.051 and 4056.052 and TEX. Gov'T CODE §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally pursuant to TEX. GOV'T CODE § 2001.056; TEX. INS. CODE § 82.055; and 28 TEX. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing pursuant to TEX. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 TEX. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default pursuant to 28 TEX. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true pursuant to 28 TEX. ADMIN. CODE § 1.89.

ORIGINAL PETITION

The Texas Department of Insurance seeks to take disciplinary action against Tanya Simmons Firmani. In support of this petition, the department makes the following allegations upon information and belief:

Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter pursuant to TEX. INS. CODE §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, 4054.51 and 4056.052, and TEX. GOV'T CODE §§ 2001.051-2001.178.

Factual Allegations

<u>Licensure</u>

- 1. Under individual identification number 1818520, Tanya Simmons Firmani (Firmani) holds a non-resident General Lines Agent license with a Life, Accident, Health and HMO qualification, originally issued by the department on September 27, 2017.
- 2. Firmani has a Texas non-resident license because she lives in Florida. This license type requires that Firmani have a resident license in good standing in her home state.



Florida Criminal Charge and Administrative Action

- 3. On June 1, 2020, Firmani was found guilty of one count of Conspiracy to Commit Bankruptcy Fraud and 6 counts of Bankruptcy Fraud in the United States District Court for the Middle District of Florida, Orlando Division.
- 4. On June 22, 2020, the Chief Financial Officer of the State of Florida entered an Order of Revocation against Firmani's Florida resident agent insurance licenses.
- 5. The order revoked Firmani's resident insurance agent licenses due to her felony convictions.
- 6. Firmani failed to notify TDI of the revocation of her home state licenses.

Legal Allegations

- 1. Firmani does not hold a license in good standing as an agent in her home state of residence, as required by TEX. INS. CODE § 4056.052, and is no longer eligible to hold a non-resident license in Texas.
- 2. Firmani failed to notify TDI of the administrative action taken against her by an insurance regulator of another state, in violation of TEX. INS. CODE § 4001.252(a)(3).

Relief Sought

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. revoking Tanya Simmons Firmani's license and
- 2. imposing any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.
