General remarks and official action taken:

This is a default order taken against Tyrone Tremaine Hudson (Respondent) because he engaged in fraudulent and dishonest practices by obtaining credit card information and entering payments without the cardholders' knowledge or consent, and he engaged in the unauthorized business of insurance. Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order revokes Respondent's license.

The following findings of fact and conclusions of law are adopted:

Findings of Fact

Failure to Respond to Notice of Hearing

- On September 10, 2020, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.

- 3. The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department, Houston, TX 77056. The Notice of Hearing and Original Petition were also sent to two additional addresses associated with Respondent: Houston, TX 77056 and P.O. Box 1615, Houston, TX 77251-1615.
- 4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

Conclusions of Law

- 1. The commissioner has jurisdiction pursuant to Texas law, including Tex. Ins. Code §§ 82.051-82.055, 84.021-84.044, 4001.002, 4005.101, 4005.101, 4005.102, and 4054.051, and Tex. Gov't Code §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally pursuant to Tex. GOV'T CODE § 2001.056; Tex. Ins. Code § 82.055; and 28 Tex. Admin. Code §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing pursuant to Tex. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 Tex. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default pursuant to 28 Tex. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true pursuant to 28 Tex. Admin. Code § 1.89.

ORIGINAL PETITION

The Texas Department of Insurance seeks to take disciplinary action against Tyrone Tremaine Hudson. In support of this petition, the department makes the following allegations upon information and belief:

Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter pursuant to Tex. Ins. Code §§ 82.051-82.055, 84.021-84.044, 4001.002, 4005.101, 4005.102, and 4054.051, and Tex. Gov't Code §§ 2001.051-2001.178.

Factual Allegations

Licensure and Background

- Tyrone Tremaine "Trae" Hudson (Hudson), individual identification no. 969906, holds a general lines agent license with a life, accident, and health qualification originally issued by the Texas Department of Insurance on August 31, 2016.
- Hudson is the sole director of Hudson Asset Management Inc. (HMI). HMI registered as a corporation with the Office of the Secretary of State of Texas on October 10, 2017. On February 28, 2020, HMI's certificate of formation was forfeited.
- On November 30, 2017, Hudson enrolled HMI with ePayPolicy, a company which
 offers a solution for insurance agents, brokers, managing general agents, and

premium finance companies to collect credit card and Automatic Clearing House payments.

4. Hudson is engaging or has engaged in the business of insurance through HMI. HMI had a website on which Hudson was listed as a contact. HMI has never been licensed or registered with the department.

Dishonest/Fraudulent Conduct

- 5. From March 2018 to May 1, 2018, Hudson fraudulently obtained 21 different credit card numbers and entered a total of 21 payments through ePayPolicy, totaling \$12,967.18. There is no evidence these cardholders were aware of the payments submitted on their behalf or were customers of Hudson. These payments were later disputed by the cardholders and resulted in chargebacks to ePayPolicy.
- 6. Hudson was contacted by ePayPolicy in early May 2018 when the payments resulted in chargebacks. Hudson claimed an employee entered those payments and kept the funds. Hudson also claimed he filed a police report in Harris County on this employee. A copy of the police report was requested, which Hudson failed to provide. There is no evidence a police report was ever filed by Hudson on this matter.
- 7. EPayPolicy attempted to recoup payment for the chargebacks from the bank account supplied by Hudson when he enrolled his company with ePayPolicy. The attempts were unsuccessful due to insufficient funds in the account. When Hudson failed to return the funds, complainant M.M. submitted a complaint to the department and filed a police report.
- 8. Hudson still owes ePayPolicy \$12,967.18 from the failed payments and \$525 in chargeback fees totaling \$13,492.18.

Failure to Respond to Department Inquiry

9. During the department's investigation, three Tex. Ins. Code § 38.001 inquiries were sent on the following dates: October 2, 2019, November 6, 2019, and November 20, 2019. Hudson failed to respond to all three.

Failure to Update Mailing Address with Department

- 10. Hudson's address of record with the department is:

 Houston, Texas 77056. The Tex. Ins. Code § 38.001 inquiries sent October 2, 2019, and November 6, 2019, were returned unclaimed. Hudson has not replied to any correspondence sent to this address.
- Hudson's address of record with the Office of the Secretary of State of Texas is:

 Houston, Texas 77056. The Tex. Ins. Code § 38.001 inquiry sent on November 20, 2019, was marked by USPS as "Forward Time Exp Rtn To Send" and included a new address, P.O. Box 1615, Houston, TX 77251-1615. Hudson failed to update the department of this change of mailing address.

Legal Allegations

- 1. Hudson committed acts for which a license holder may be disciplined under TEX. INS. CODE § 4005.101, as contemplated in TEX. INS. CODE § 4005.102.
- 2. Hudson willfully violated an insurance law of this state, pursuant to Tex. Ins. Code § 4005.101(b)(1).
- 3. Hudson engaged in fraudulent or dishonest acts or practices, pursuant to Tex. INS. CODE § 4005.101(b)(5).
- 4. Hudson engaged in acts constituting the business of insurance without a license, as defined in Tex. Ins. Code §§ 101.051 and 4001.051, in violation of Tex. Ins. Code §§ 101.102, 4001.101, 4054.051, and 28 Tex. Admin. Code § 19.902.
- 5. Hudson failed to register an assumed name by filing with the department a completed form LDTL together with the required fee, in violation of 28 TEX. ADMIN. CODE § 19.902.
- 6. Hudson failed to respond to three separate requests for information, pursuant to Tex. Ins. Code § 38.001(c).
- 7. Hudson failed to notify the department of a change of address, pursuant to Tex. INS. CODE § 4001.252

Relief Sought

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. revoking Hudson's license;
- 2. directing Hudson to pay an administrative penalty under Tex. INS. CODE §§ 84.021-84.044;
- 3. directing Hudson to pay restitution to ePayPolicy;
- 4. directing Hudson to cease and desist conducting the business of insurance under the name Hudson Asset Management Inc., an unlicensed entity; and
- 5. imposing any other just and appropriate relief to which the Department may be entitled to by law, including any combination of the above actions.
