General remarks and official action taken:

The subject of this default order is whether a general lines agent license should be issued to Shaqueen Walker (Respondent). Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order denies Respondent's license application.

The following findings of fact and conclusions of law are adopted:

Findings of Fact

Failure to Respond to Notice of Hearing

- On November 3, 2020, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.

- 3. The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department, Bastrop, TX 78602-7702.
- 4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

Conclusions of Law

- 1. The commissioner has jurisdiction pursuant to Texas law, including Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, and 4101.051; 28 Tex. ADMIN. CODE § 1.502; Tex. Occ. Code §§ 53.021 53.023; and Tex. Gov't. Code §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally pursuant to Tex. GOV'T CODE § 2001.056; Tex. Ins. CODE § 82.055; and 28 Tex. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing pursuant to Tex. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 Tex. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default pursuant to 28 Tex. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true pursuant to 28 Tex. Admin. Code § 1.89.

ORIGINAL PETITION

The Texas Department of Insurance seeks to deny Shaqueen Walker's license application. In support of this petition, the department makes the following allegations upon information and belief:

Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter pursuant to Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, and 4051.051; 28 Tex. Admin. Code §§ 1.502; Tex. Occ. Code §§ 53.021 – 53.023; and Tex. Gov't Code §§ 2001.051-2001.178.

Factual Allegations

Licensing Application

- 1. Shaqueen Walker (Walker) submitted an application for a general lines property and casualty license to the Texas Department of Insurance (TDI) on April 1, 2019.
- 2. On June 13, 2019, TDI proposed to deny the license based on Walker's criminal history.
- 3. On June 27, 2019, Walker requested a hearing on this matter.

Criminal History

4. On May 30, 2007, Walker was Indicted for three counts of aggravated robbery with a deadly weapon, a first-degree felony offense, in the 403rd Judicial District of Travis County, Texas. The case was transferred to the 427th District where Walker pleaded guilty on December 15, 2008, to the lesser included offense of robbery, a second-degree felony, in exchange for seven years deferred adjudication in Cause No. 202521. Walker was released from deferred adjudication community supervision on December 16, 2015. Walker failed to provide the department with evidence that she paid the \$2,600 Court ordered restitution.

Legal Allegation

- 1. Walker's offense in Cause No. 202521 may be considered a felony conviction, for the purpose of licensing, because she completed the period of supervision less than five years before the date she applied for the license, as contemplated under Tex. Occ. Code § 53.021(d)(1)(B)(i), and the department determined that she may pose a continued threat to public safety, as contemplated under Tex. Occ. Code § 53.021(d)(2)(A).
- 2. Walker has been convicted of a felony as contemplated under Tex. INS. CODE § 4005.101(b)(8) and Tex. Occ. CODE § 53.021.
- 3. Walker has engaged in fraudulent or dishonest acts or practices as contemplated by Tex. Ins. Code § 4005.101(b)(5).
- 4. Department guidelines, 28 Tex. ADMIN. CODE § 1.502(c)-(e), emphasize that the department:
 - a. considers it very important that applicants be honest, trustworthy, and reliable;
 - b. may refuse to issue an original license if the department determines that the applicant has committed a felony or misdemeanor that directly relates to the duties and responsibilities of the licensed occupation;
 - c. considers the offense of robbery to be of such a serious nature that it is of prime importance when determining fitness for licensure.

Relief Sought

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. denying Walker's license application and
- 2. imposing any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.
