#### General remarks and official action taken:

The subject of this default order is whether a general lines agent license should be issued to Roscelyn Larhonda Walton (Respondent). Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order denies Respondent's license application.

The following findings of fact and conclusions of law are adopted:

#### **Findings of Fact**

#### Failure to Respond to Notice of Hearing

- On December 3, 2020, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.

- 3. The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department, Lewisville, TX 75057.
- 4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

#### **Conclusions of Law**

- 1. The commissioner has jurisdiction pursuant to Texas law, including TEX. INS. CODE §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, and 4101.051; 28 TEX. ADMIN. CODE § 1.502; TEX. OCC. CODE §§ 53.021 53.023; and TEX. GOV'T. CODE §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally pursuant to TEX. GOV'T CODE § 2001.056; TEX. INS. CODE § 82.055; and 28 TEX. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing pursuant to TEX. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 TEX. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default pursuant to 28 TEX. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true pursuant to 28 TEX. ADMIN. CODE § 1.89.

#### **ORIGINAL PETITION**

The Texas Department of Insurance seeks to deny Roscelyn Larhonda Walton's license application. In support of this petition, the department makes the following allegations upon information and belief:

#### Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter pursuant to TEX. INS. CODE §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, and 4051.051; 28 TEX. ADMIN. CODE § 1.502; TEX. OCC. CODE §§ 53.021 – 53.023; and TEX. GOV'T CODE §§ 2001.051-2001.178.

#### **Factual Allegations**

Licensing Application

- Roscelyn Larhonda Walton (Walton) submitted an application for a general lines property and casualty license to the Texas Department of Insurance (TDI) on July 15, 2019, in which she failed to disclose her criminal history.
- 2. On September 30, 2019, TDI proposed to deny the license based on Walton's criminal history and her failure to disclose said criminal history.
- 3. On October 16, 2019, Walton requested a hearing on this matter.

#### Criminal History

4. On April 14, 2008, Walton pleaded guilty to Securing Execution of Document by Deception, a felony offense, and was placed on five years deferred adjudication and ordered to repay \$14,922 in restitution in Case No. F0700308X in Dallas County District Court No. 6. Walton's deferment was extended to eight years and she was unsuccessfully discharged on April 14, 2016. Walton failed to provide the department with evidence that she paid the \$14,922 Court ordered restitution.

#### Legal Allegation

- 5. Walton has made a material misstatement in the application, in violation of TEX. INS. CODE § 4005.101(b)(2).
- 6. Walton has attempted to obtain a license by misrepresentation, in violation of TEX. INS. CODE § 4005.101(b)(3).
- 7. Walton has been convicted of a felony, for the purpose of licensing, as contemplated by TEX. INS. CODE § 4005.101(b)(8) and TEX. OCC. CODE § 53.021.
- 8. Walton has engaged in fraudulent or dishonest acts or practices, as contemplated by TEX. INS. CODE § 4005.101(b)(5).
- 9. Walton's offense in Cause No. 202521 may be considered a conviction, for purposes of licensing, because she completed the period of supervision less than five years before the date she applied for the license, as contemplated under TEX. OCC. CODE § 53.021(d)(1)(B)(i), and the department determined that she may pose a continued threat to public safety, as contemplated under TEX. OCC. CODE § 53.021(d)(2)(A).
- 10. Walton has committed an offense directly related to the business of insurance as contemplated by 28 TEX. ADMIN. CODE § 1.502(f).
- 11. Walton committed an offense that the department considers to be of such a serious nature that it is of prime importance in determining fitness for licensure, as contemplated by 28 TEX. ADMIN. CODE § 1.502(e)(4)(D) and TEX. OCC. CODE § 53.021-53.023.

- 12. Department guidelines, 28 TEX. ADMIN. CODE § 1.502(c)-(e), emphasize that the department:
  - a. considers it very important that applicants be honest, trustworthy, and reliable;
  - b. may refuse to issue an original license if the department determines that the applicant has committed a felony or misdemeanor that directly relates to the duties and responsibilities of the licensed occupation;
  - c. considers any offense for which fraud, dishonesty, or deceit is an essential element; any felony involving moral turpitude or breach of fiduciary duty; or containing the essential elements of theft, to be of such a serious nature that it is of prime importance when determining fitness for licensure. 28 TEX. ADMIN. CODE § 1.502(e)(1),(3), & (4)(F).

### **Relief Sought**

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. denying Walton's license application and
- 2. imposing any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.


