General remarks and official action taken:

This is a default order taken against Brio Insurance Brokers Inc. (Respondent) because Respondent failed to properly notify insured of agent fees and failed to obtain a signature on the required written disclosure. Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order revokes Respondent's license.

The following findings of fact and conclusions of law are adopted:

Findings of Fact

Failure to Respond to Notice of Hearing

- 1. On December 11, 2020, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.
- 3. The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department, 719 E. Parker Rd.,

Houston, TX 77076-3412. The Notice of Hearing and Original Petition were also sent to Respondent by electronic mail.

4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

Conclusions of Law

- 1. The commissioner has jurisdiction pursuant to Texas law, including Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4001.102, 4001.105, 4005.101-4005.105, 4051.051 and 4101.051; Tex. Occ. Code §§ 53.021-53.023; 28 Tex. Admin. Code § 1.502; and Tex. Gov't Code §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally pursuant to Tex. GOV'T CODE § 2001.056; Tex. Ins. CODE § 82.055; and 28 Tex. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing pursuant to Tex. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 Tex. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default pursuant to 28 Tex. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true pursuant to 28 Tex. Admin. Code § 1.89.

ORIGINAL PETITION

The Texas Department of Insurance seeks to take disciplinary action against Brio Insurance Brokers Inc. In support of this petition, the department makes the following allegations upon information and belief:

Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter pursuant to Tex. Ins. Code §§ 82.051-82.055, 84.021-84.044 4001.002, 4005.101, 4005.102, and 4051.051, and Tex. Gov't Code §§ 2001.051-2001.178.

Factual Allegations

- 1. Brio Insurance Brokers Inc (Brio), organization identification number 147510, holds a general lines agency license with a property and casualty qualification issued by the Texas Department of Insurance (TDI) on September 4, 2018.
- 2. Brio charged and collected \$1,387.75 from S.S., an insured, for Atlantic Casualty Insurance Company policy number xxxxxx9722.
- 3. The total premium including taxes and fees for Atlantic Casualty Insurance Company policy number xxxxxx9722 was \$687.75.
- 4. Brio charged and collected \$700.00 in agent fees from S.S., an insured, and failed to properly notify her they were charging the fee and failed to obtain her signature on a written disclosure regarding the agent fee prior to providing the service.

Legal Allegations

- 1. Brio materially misrepresented the terms and conditions of insurance policies or contracts, as contemplated by Tex. INS. CODE § 4005.101(b)(6).
- 2. Brio engaged in fraudulent or dishonest acts or practices, as contemplated by TEX. INS. CODE § 4005.101(b)(5).
- 3. Brio did not properly notify a client, as required by 28 Tex. ADMIN. CODE § 19.1503, that it was charging a policy fee, agent fee, service fee, inspection fee, and/or reimbursement fee pursuant to Tex. Ins. Code §§ 4005.003 and/or § 550.001.
- 4. Brio failed to comply with 28 Tex. ADMIN. CODE § 19.1503 which states that an agent must obtain the client's signature on a written disclosure form which:
 - a. Notifies the client, prior to incurring the expense or providing the service, of the fee charged by the agent;
 - b. Contains the toll-free telephone number of the Texas Department of Insurance and the required bold-face statement; and
 - c. Contains a complete itemized list of the fees being charged and, if a service fee is charged, a complete itemized listing of the services provided and the corresponding charge for each item under the service fee.

Relief Sought

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. revoking Brio Insurance Brokers Inc's license;
- 2. ordering Brio Insurance Brokers Inc to cease and desist from certain activity or conduct;
- 3. directing Brio Insurance Brokers Inc to pay an administrative penalty under Tex. INS. Code §§ 84.021 84.022;
- 4. directing Brio Insurance Brokers Inc to make restitution to victim under Tex. INS. Code § 82.053; and
- 5. imposing any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.
