#### General remarks and official action taken:

This is a default order taken against Roman Galvan (Respondent) because he engaged in the unauthorized business of insurance, misappropriated insurance premiums, engaged in fraudulent and dishonest acts, and failed to respond to official department inquiries. Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order revokes Respondent's license.

The following findings of fact and conclusions of law are adopted:

#### Findings of Fact

#### Failure to Respond to Notice of Hearing

- On October 16, 2020, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.

3. The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department, Houston, Texas 77041-8612. The Notice of Hearing and Original Petition were also sent to two additional addresses associated with Respondent: , Cypress, Texas 77433-2543 and John Market Mark

77070-4730.

4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

# **Conclusions of Law**

- 1. The commissioner has jurisdiction pursuant to Texas law, including TEX. INS. CODE §§ 82.051-82.055, 84.021-84.044, 4001.002, 4001.101, 4005.102, and 4051.101, and TEX. GOV'T CODE §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally pursuant to TEX. GOV'T CODE § 2001.056; TEX. INS. CODE § 82.055; and 28 TEX. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing pursuant to TEX. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 TEX. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default pursuant to 28 TEX. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true pursuant to 28 TEX. ADMIN. CODE § 1.89.

### ORIGINAL PETITION

The Texas Department of Insurance seeks to take disciplinary action against Roman Galvan. In support of this petition, the department makes the following allegations upon information and belief:

# Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter pursuant to TEX. INS. CODE §§ 82.051-82.055, 84.021-84.044, 4001.002, 4001.101, 4005.101, 4005.102, and 4051.101, and TEX. GOV'T CODE §§ 2001.051-2001.178.

# **Factual Allegations**

Licensure and Background

1. Roman Galvan (Galvan), individual identification no. 1942531, holds a limited lines agent license, originally issued by Texas Department of Insurance on October 3, 2018.

### Unauthorized Business of Insurance

2. In March of 2017, over one and a half years before he was issued an insurance license by the department, Galvan represented himself as a licensed insurance agent to complainant M.F. when she requested an automobile insurance policy.

3. On October 10, 2017, one year prior to his licensure, Galvan represented himself as a licensed insurance agent during an interview with a third-party investigator regarding the policy sold to M.F.

### Fictitious Policies and Insurance Documents

- 4. On March 10, 2017, Galvan sold M.F. a fictitious automobile insurance policy for \$100 and provided M.F. a fictitious identification card.
- 5. On April 10, 2017, M.F.'s husband was involved in an automobile accident with a Nationwide policyholder. Insurance information was exchanged at the scene of the accident. A few days later, Nationwide called M.F. and explained she did not hold a valid insurance policy. The damage to Nationwide's insured was covered by uninsured/underinsured motorist coverage for a total of \$20,532. M.F.'s vehicle sustained heavy damage which necessitated the purchase of a new vehicle.
- 6. During the October 10, 2017, interview with the investigator, Galvan stated he did not sell M.F. an insurance policy, but rather "proof of insurance" to use for "court purposes." Galvan admitted to the investigator that he used the information from a previous insured's expired policy and changed it to M.F.'s information.
- 7. The investigator asked Galvan how many times he sold this type of "proof of insurance" and Galvan stated it was less than 10 times. Galvan admitted he knew what he did was wrong.

### Failure to Respond to Department Inquiry

8. During the department's investigation, the department sent four inquiries pursuant to TEX. INS. CODE § 38.001 to Galvan. On June 12, 2019, inquiries were sent to the email address, home address, and business address on file with the department. On July 2, 2019, an additional inquiry was sent to an address discovered during the department's investigation. Galvan failed to respond to all four inquiries.

# Legal Allegations

1. Galvan held himself out as a licensed insurance agent prior to his licensure by the department, in violation of TEX. INS. CODE §§ 101.102, 4001.101 and 4051.101.

- 2. Galvan committed acts for which a license holder may be disciplined under TEX. INS. CODE § 4005.101, as contemplated by TEX. INS. CODE § 4005.102.
- 3. Galvan willfully violated an insurance law of this state, pursuant to TEX. INS. CODE § 4005.101(b)(1).
- 4. Galvan misappropriated, converted to his own use, or illegally withheld money belonging to an insurer or an insured, pursuant to TEX. INS. CODE § 4005.101(b)(4).
- 5. Galvan engaged in fraudulent or dishonest acts or practices, in violation of TEX. INS. CODE § 4005.101(b)(5).
- 6. Galvan failed to respond to official inquiries sent by the department, in violation of TEX. INS. CODE § 38.001(c).

# **Relief Sought**

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. revoking Galvan's license;
- 2. directing Galvan to pay an administrative penalty under TEX. INS. CODE §§ 84.021-84.022;
- 3. directing Galvan to make restitution to victims(s) under TEX. INS. CODE § 82.053; and
- 4. imposing any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.


