General remarks and official action taken:

This is a default order taken against Matthew Martin Gandy (Respondent) because he misappropriated insurance premiums and engaged in fraudulent and dishonest acts. Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order revokes Respondent's licenses.

The following findings of fact and conclusions of law are adopted:

Findings of Fact

Failure to Respond to Notice of Hearing

- On November 23, 2020, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.
- The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department,

4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

Conclusions of Law

- 1. The commissioner has jurisdiction pursuant to Texas law, including Tex. Ins. Code §§ 82.051-82.055, 84.021-84.044, 4001.002, 4005.101, 4005.102, 4051.051, and 4054.051, and Tex. Gov't Code §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally pursuant to Tex. GOV'T CODE § 2001.056; Tex. Ins. CODE § 82.055; and 28 Tex. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing pursuant to Tex. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 Tex. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default pursuant to 28 Tex. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true pursuant to 28 Tex. Admin. Code § 1.89.



ORIGINAL PETITION

The Texas Department of Insurance seeks to take disciplinary action against Matthew Martin Gandy. In support of this petition, the department makes the following allegations upon information and belief:

Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter pursuant to Tex. Ins. Code §§ 82.051-82.055, 84.021-84.044, 4001.002, 4005.101, 4005.102, 4051.051, and 4054.051, and Tex. Gov't Code §§ 2001.051-2001.178.

Factual Allegations

Licensure and Background

- Matthew Martin Gandy (Gandy), individual identification no. 339234, holds a
 general lines agent license with a property and casualty qualification issued by the
 department on February 27, 2006, and a life, accident, and health qualification,
 issued on March 3, 2006.
- 2. Gandy was appointed by State Farm in March 2006, until the company canceled his appointments in August 2019.

Fraudulent and Dishonest Conduct

- 3. State Farm became aware of discrepancies in Gandy's Premium Fund Account (PFA) after attempting multiple unsuccessful withdrawals, in 2018 and 2019, via Electronic Funds Transfer (EFT).
- 4. State Farm conducted a reconciliation and detailed audit of Gandy's PFA in 2019, reviewing the period of July 1, 2018, through February 28, 2019, which revealed extensive misappropriation of agency funds by Gandy. When questioned by State Farm investigators on May 8, 2019, Gandy admitted to the misappropriation.
- 5. When a State Farm Agency collects a customer's payment, it applies the payment to the customer's policy and records it on the Final Deposit Listing (FDL). Then, the payment is deposited in the PFA, enabling State Farm to withdraw the funds. The FDL and PFA must match in both amount and detail.
- 6. Gandy deposited six personal checks into the PFA during the reviewed period, totaling \$3,245.47, in an attempt to cover missing funds.
- 7. During the investigation, State Farm found 29 checks deposited into the PFA before they were applied to customer policies. This is typically seen when an agent uses customer payments to cover past payments which were misappropriated. A practice commonly known as a "lapping scheme."
- 8. State Farm's investigation revealed 44 checks, totaling \$21,836.68, listed on the FDLs, but which were not found on the PFA bank deposit detail. This includes one of Gandy's personal checks written for his personal insurance policy.
- 9. Gandy wrote a check for \$741.92 from his personal checking account for his personal insurance policy. These funds were applied to his policy and recorded on the FDL. Then Gandy deposited the check into his personal business account instead of his PFA. Gandy's personal business account was located at the same bank as the PFA, but State Farm had no access to that account. Gandy repaid himself by depositing the funds from his personal checking account into his personal business account and then allowed State Farm to withdraw funds already in the PFA to cover the amount he owed for his personal policy. Gandy admitted this during the interview with the investigators. When asked if he thought these

- actions constituted "stealing" from State Farm, Gandy admitted that his actions did constitute stealing.
- 10. During this same conversation with investigators, Gandy was shown a list of all customer checks unaccounted for during State Farm's audit. He admitted to depositing all 43 customer checks, totaling \$21,094.76, in his personal business account rather than into the PFA. The investigator stressed it would "be very alarming if any of these customer checks were floating around somewhere," and Gandy, "assured her all were deposited into his business account."
- 11. During the interview with State Farm's internal audit investigators, Gandy admitted misappropriating funds from the PFA in excess of \$45,000 for his personal use, and creating a "lapping scheme" by using customer payments to cover past payments which were deposited into his personal business account for personal use.
- 12. Initially in the interview, Gandy claimed he borrowed \$45,000 from a friend to pay State Farm back and that the money was then stolen out of his truck. When pressed on the story, Gandy "raised his hands up high and said, nope, admitting he made the entire story up to cover his theft of State Farm funds."
- 13. In direct communication with the department in October 2019, Gandy stated that he "paid the money back in 2 1/2 months" and "It was not even communicated that I paid it back." These statements directly contradict the fact that as of August 6, 2019,—three months after he admitted to misappropriation of funds—he still owed State Farm \$16,078.42.
- 14. As of February 28, 2019, Gandy owed State Farm \$52,536.39. State Farm has a first lien on Gandy's compensation and exercised its right to withhold earnings. As of August 31, 2020, Gandy still owed State Farm \$9,084.73.

Legal Allegations

- 1. Gandy committed acts for which a license holder may be disciplined under Tex. INS. CODE § 4005.101, as contemplated in Tex. INS. CODE § 4005.102.
- 2. Gandy willfully violated an insurance law of this state, pursuant to Tex. Ins. Code § 4005.101(b)(1).

- 3. Gandy misappropriated, converted to his own use, or illegally withheld money belonging to an insurer or an insured, pursuant to Tex. Ins. Code § 4005.101(b)(4).
- 4. Gandy engaged in fraudulent or dishonest acts or practices, pursuant to Tex. INS. CODE § 4005.101(b)(5).

Relief Sought

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. revoking Matthew Martin Gandy's license;
- 2. directing Matthew Martin Gandy to pay an administrative penalty under Tex. INS. CODE §§ 84.021 84.022;
- 3. directing Matthew Martin Gandy to make restitution to the victim under Tex. INS. Code § 82.053; and
- 4. imposing any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.
