General remarks and official action taken:

This is a default order taken against Brendanwood Financial Brokerage LLC (Respondent) because Respondent failed to notify the department of other administrative actions taken in its resident state of Indiana and the state of Michigan. Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order revokes Respondent's license.

The following findings of fact and conclusions of law are adopted:

Findings of Fact

Failure to Respond to Notice of Hearing

- 1. On January 12, 2021, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.

- 3. The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department, 9650 North Commerce Dr., Suite 523, Carmel, IN 46032. The Notice of Hearing and Original Petition were also sent by electronic mail.
- 4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

Conclusions of Law

- 1. The commissioner has jurisdiction pursuant to Texas law, including Tex. INS. CODE §§ 82.051-82.055, 4001.002, 4001.102, 4001.105, 4005.101-4005.105, 4054.051, and 4101.051; Tex. Occ. Code §§ 53.021-53.023; 28 Tex. Admin. Code § 1.502; and Tex. Gov't Code §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally pursuant to TEX. GOV'T CODE § 2001.056; TEX. INS. CODE § 82.055; and 28 TEX. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing pursuant to TEX. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 TEX. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default pursuant to 28 TEX. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true pursuant to 28 TEX. ADMIN. CODE § 1.89.

The Texas Department of Insurance seeks to take disciplinary action against Brendanwood Financial Brokerage LLC. In support of this petition, the department makes the following allegations upon information and belief:


Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter pursuant to TEX. INS. CODE §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, and 4054.051, and TEX. GOV'T CODE §§ 2001.051-2001.178.

Factual Allegations

- 1. Brendanwood Financial Brokerage LLC (Brendanwood), organization identification number 104988, holds a general lines agency license with a life, accident, health, and HMO qualification issued by the Department on May 3, 2016.
- 2. Brendanwood's license was suspended by its resident state of Indiana on July 9, 2020, for failing to provide a list of appointments to the Commissioner.
- 3. Brendanwood's license was revoked by the state of Michigan on July 7, 2020, for failing to register a designated responsible licensed person for the entity.

Brendanwood failed to report the administrative actions of other states to the Texas Department of Insurance within 30 days.



Legal Allegations

- 1. Brendanwood failed to notify the Department, on a monthly basis, of administrative actions taken against them by a financial or insurance regulator for the State of Texas, another state or by the United States as required by TEX. INS. CODE § 4001.252(a)(2).
- 2. Brendanwood failed to notify and deliver a copy of any document or Order from another State to the Department, pursuant to TEX. INS. CODE § 81. 003, within 30 days of the occurrence of suspension or revocation of its right to transact business.

Relief Sought

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:


- 1. revoking Brendanwood Financial Brokerage LLC's license and
- 2. imposing any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.
