#### General remarks and official action taken:

This is a default order taken against Salvador Villarreal, Jr. (Respondent) because he engaged in fraudulent or dishonest acts or practices and failed to meet the qualification to be actively engaged in writing insurance for the public. Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order revokes Respondent's license.

The following findings of fact and conclusions of law are adopted:

#### Findings of Fact

- 1. On March 2, 2021, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.
- The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department,
   , El Paso, TX 79912.

4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

#### **Conclusions of Law**

- 1. The commissioner has jurisdiction pursuant to Texas law, including TEX. INS. CODE §§ 82.051-82.055, 4001.002, 4001.102, 4001.105, 4005.101, 4051.051, and 4054.051; TEX. OCC. CODE §§ 53.021-53.023; 28 TEX. ADMIN. CODE § 1.502; and TEX. GOV'T CODE §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally pursuant to TEX. GOV'T CODE § 2001.056; TEX. INS. CODE § 82.055; and 28 TEX. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing pursuant to TEX. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 TEX. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default pursuant to 28 TEX. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true pursuant to 28 TEX. ADMIN. CODE § 1.89.

#### **ORIGINAL PETITION**

The Texas Department of Insurance seeks to take disciplinary action against you. In support of this petition, the department makes the following allegations upon information and belief:

#### Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter pursuant to TEX. INS. CODE §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, 4005.103, 4051.051, 4054.051 and TEX. GOV'T CODE §§ 2001.051-2001.178.

### **Factual Allegations**

- 1. Salvador Villarreal, Jr. (Villarreal), individual identification no. 1270973, holds a general lines agent license with a property and casualty qualification originally issued by the Texas Department of Insurance (TDI) on November 6, 2014, and a life, accident, health, and HMO qualification issued by TDI on March 25, 2015.
- 2. On or about August 5, 2020, all of Villarreal's appointments with the Allstate companies were terminated following an investigation into dishonest conduct and falsification of documents, leaving Villarreal with no active appointments.
- 3. Between December 18, 2019, and February 19, 2020, Villarreal uploaded false documents to obtain discounts for customers, which they would not otherwise qualify, and provided additional misleading information in an attempt to cover up the falsity of the documents.

### EXHIBIT

#### Legal Allegations

- 1. Villarreal committed acts for which a license holder may be disciplined under TEX. INS. CODE § 4005.101, as contemplated by TEX. INS. CODE § 4005.102.
- 2. Villarreal willfully violated insurance laws of this state, pursuant to TEX. INS. CODE § 4005.101(b)(1).
- 3. Villarreal engaged in fraudulent or dishonest acts or practices, in violation of TEX. INS. CODE § 4005.101(b)(5).
- 4. Villareal failed to meet the qualifications to be actively engaged in soliciting or engaging in writing insurance for the public generally, in violation of TEX. INS. CODE §§ 4005.101(b)(10) and 4001.104(1).

### **Relief Sought**

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. revoking Salvador Villarreal, Jr.'s license and
- 2. imposing any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.


