General remarks and official action taken:

This is a default order taken against Jennifer Diane Perdiz (Respondent) because she engaged in fraudulent or dishonest acts or practices, failed to meet the terms and conditions of her probationary license agreement, and failed to meet the qualification to be actively engaged in writing insurance for the public. Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order revokes Respondent's license.

The following findings of fact and conclusions of law are adopted:

Findings of Fact

- On March 3, 2021, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.

- 3. The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department, TX 79915.
- 4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

Conclusions of Law

- 1. The commissioner has jurisdiction pursuant to Texas law, including Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4001.102, 4001.105, 4005.101, and 4051.051; Tex. Occ. Code §§ 53.021-53.023; 28 Tex. Admin. Code § 1.502; and Tex. Gov't Code §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally pursuant to Tex. GOV'T CODE § 2001.056; Tex. Ins. CODE § 82.055; and 28 Tex. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing pursuant to Tex. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 Tex. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default pursuant to 28 Tex. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true pursuant to 28 Tex. Admin. Code § 1.89.



ORIGINAL PETITION

The Texas Department of Insurance seeks to take disciplinary action against you. In support of this petition, the department makes the following allegations upon information and belief:

Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter pursuant to Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, 4005.103, 4051.051, and Tex. Gov't Code §§ 2001.051-2001.178.

Factual Allegations

- 1. On May 18, 2020, Jennifer Diane Perdiz (Perdiz) signed a "Term sheet for probated agent license," indicating the terms and conditions required to be issued and maintain a license from the Texas Department of Insurance (TDI).
- 2. On May 21, 2020, TDI issued Perdiz, individual identification no. 2087946, a general lines agent probated license with a property and casualty qualification. This license was probated for a period of two years due to Perdiz's criminal history and for her failure to disclose her criminal history on her application for licensure.
- On May 21, 2020, Perdiz submitted her first and only report to TDI, required under her probationary terms and conditions, indicating her employment with "Salvador Villarreal at Salvador Villarreal insurance agency and Allstate company."

- 4. On August 5, 2020, all of Perdiz's appointments with Allstate companies were terminated following an investigation into dishonest conduct and falsification of documents, leaving Perdiz with no active appointments.
- 5. At some point during her employment with Salvador Villarreal, Perdiz provided false documents in order to obtain discounts for customers, which they would not otherwise qualify, and provided additional misleading information in an attempt to cover up the falsity of the documents.

Legal Allegations

- 1. Perdiz committed acts for which a license holder may be disciplined under Tex. INS. CODE § 4005.101, as contemplated by Tex. INS. CODE § 4005.102.
- 2. Perdiz willfully violated insurance laws of this state, pursuant to Tex. Ins. Code § 4005.101(b)(1).
- 3. Perdiz engaged in fraudulent or dishonest acts or practices, in violation of Tex. INS. CODE § 4005.101(b)(5).
- 4. Perdiz failed to meet the qualifications to be actively engaged in soliciting or engaging in writing insurance for the public generally, in violation of Tex. Ins. Code 4005.101(b)(10) and §§ 4001.104(1).
- 5. Perdiz failed to meet the terms and conditions of her probationary license agreement, in violation of Tex. INS. CODE § 4005.103.

Relief Sought

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. revoking Jennifer Diane Perdiz's license and
- 2. imposing any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.
