General remarks and official action taken:

This is a default order taken against Millenium Insurance Agency Inc (Respondent) because they did not notify the Texas Department of Insurance of the administrative action taken against them. Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order revokes Respondent's license.

The following findings of fact and conclusions of law are adopted:

Findings of Fact

- 1. On February 24, 2021, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.
- 3. The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department, 1953 Gallows Rd., Suite 185, Vienna, VA 22182-3997.

4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

Conclusions of Law

- 1. The commissioner has jurisdiction pursuant to Texas law, including Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4001.102, 4001.105, 4005.101, and 4056.054; Tex. Occ. Code §§ 53.021-53.023; 28 Tex. Admin. Code § 1.502; and Tex. Gov't Code §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally pursuant to Tex. GOV'T CODE § 2001.056; Tex. Ins. Code § 82.055; and 28 Tex. Admin. Code §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing pursuant to Tex. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 Tex. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default pursuant to 28 Tex. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true pursuant to 28 Tex. Admin. Code § 1.89.

Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter pursuant to Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4005.101, 4001.252, and 4056.054, and Tex. Gov't Code §§ 2001.051-2001.178.

Fact Allegations

- 1. Millenium Insurance Agency Inc (MIA), firm identification number 135668, holds a non-resident agency license with a life, accident, health, and HMO qualification originally issued on September 19, 2017, and a property and casualty qualification issued on March 10, 2018, by the Texas Department of Insurance.
- 2. MIA's home state license was issued by Virginia where the entity is incorporated.
- 3. MIA's license to transact the business of insurance in Virginia was revoked by Order of the State Corporation Commission on December 10, 2020.

Legal Allegation

4. MIA failed to notify TDI of the administrative action taken by Virginia, in violation of Tex. Ins. Code § 4001.252(a)(3).

Relief Sought

If the above allegation is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. revoking Millenium Insurance Agency Inc's license and
- 2. imposing any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.
