#### General remarks and official action taken:

This is a default order taken against Eli Ivan Castillo (Respondent) because he operated an unlicensed agency, issued fictitious insurance certificates, and misappropriated premiums. Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order revokes Respondent's license.

The following findings of fact and conclusions of law are adopted:

#### **Findings of Fact**

#### Failure to Respond to Notice of Hearing

- 1. On March 9, 2021, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.
- 3. The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department,

Houston, Texas 77076. The Notice of Hearing and Original Petition were also sent by electronic mail.

4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

### **Conclusions of Law**

- 1. The commissioner has jurisdiction pursuant to Texas law, including Tex. INS. CODE §§ 82.051-82.055, 4001.002, 4001.102, 4001.105, 4005.101-4005.105, 4051.051 and 4101.051; Tex. Occ. CODE §§ 53.021-53.023; 28 Tex. ADMIN. CODE § 1.502; and Tex. GOV'T CODE §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally pursuant to TEX. GOV'T CODE § 2001.056; TEX. INS. CODE § 82.055; and 28 TEX. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing pursuant to TEX. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 TEX. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default pursuant to 28 TEX. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true pursuant to 28 TEX. ADMIN. CODE § 1.89.

### **ORIGINAL PETITION**


The Texas Department of Insurance seeks to take disciplinary action against Eli Ivan Castillo. In support of this petition, the department makes the following allegations upon information and belief:

### Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter pursuant to TEX. INS. CODE §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, and 4051.051, and TEX. GOV'T CODE §§ 2001.051-2001.178.

### **Factual Allegations**

- 1. Eli Ivan Castillo (Castillo), individual identification number 687424, holds a general lines license with property and casualty qualification issued by the Texas Department of Insurance (the department) on June 26, 2019.
- Castillo is the owner of the Alamo Insurance Agency located at Houston, Texas 77015. This agency does not have a valid entity license or any other authorization issued by the department.
- 3. Castillo, or Alamo Insurance Agency, retained insurance premiums from M.R. for an insurance policy and failed to place the insurance.
- 4. Castillo, or Alamo Insurance Agency, issued false or fictitious certificates of insurance to M.R.



5. The department sent a request for information pursuant to TEX. INS. CODE § 38.001 on February 11, 2021, to Castillo and he failed to respond in writing no later than the 15<sup>th</sup> day after the date the inquiry was received.

### Legal Allegations

- 1. Castillo has willfully violated an insurance law of this state, as contemplated in TEX. INS. CODE § 4005.101(b)(1).
- 2. Castillo has misappropriated, converted to his own use, or illegally withheld money belonging to an insurer, HMO, insured, enrollee, or beneficiary as contemplated in TEX. INS. CODE § 4005.101(b)(4).
- 3. Castillo has engaged in fraudulent or dishonest acts or practices, as contemplated in TEX. INS. CODE § 4005.101(b)(5).
- 4. Castillo violated TEX. INS. CODE § 101.102 by operating an insurance agency that did not hold an insurance license or other authorization issued by the Texas Department of Insurance which directly or indirectly performed acts which constitute the business of insurance as that term is defined in TEX. INS. CODE § 101.051.
- 5. Castillo violated TEX. INS. CODE § 38.001 by failing to respond to a Department inquiry in writing not later than the 15<sup>th</sup> day after the date the inquiry was received.

### **Relief Sought**

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. revoking Castillo's license;
- 2. directing Castillo to make restitution to victim under TEX. INS. CODE § 82.053; and
- 3. imposing any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.


