#### General remarks and official action taken:

This is a default order taken against Delilah Luna (Respondent) because Respondent has been convicted of a felony and is imprisoned for that felony conviction. Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order revokes Respondent's license.

The following findings of fact and conclusions of law are adopted:

#### **Findings of Fact**

# Failure to Respond to Notice of Hearing

- On June 9, 2021, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.
- On June 9, 2021, the department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department,

McAllen, Texas 78501. The Notice of Hearing and Original Petition were also sent to one additional address associated with Respondent:

, Dayton, Texas 77535.

4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

#### **Conclusions of Law**

- 1. The commissioner has jurisdiction under Texas law, including Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, and 4054.201; Tex. Occ. Code §§ 53.021-53.023; 28 Tex. Admin. Code § 1.502; and Tex. Gov't Code §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally under Tex. Gov'T CODE § 2001.056; Tex. Ins. CODE § 82.055; and 28 Tex. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing under Tex. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 Tex. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default under 28 Tex. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true under 28 Tex. ADMIN. CODE § 1.89.


# **Factual Allegations**

#### Licensure

 Delilah Luna (Luna), individual identification number 2063218, holds a life insurance not exceeding \$25,000 agent license originally issued by the department on May 29, 2019.

# Criminal History

On March 31, 2021, Luna was convicted of the 3rd degree felony offense of assault family/household member by impeding breath/circulation in cause no. CR-0039-21-D, in the 206th District Court of Hidalgo County, Texas. The court sentenced Luna to five years imprisonment in the Texas Department of Criminal Justice (TDCJ) and ordered her to pay court costs.

- 3. Also, on March 31, 2021, Luna was convicted of the 1st degree felony offense of manufacturing delivery of controlled substance pg 1>=4g<200g in cause no. CR-3473-19-D, in the 206th District Court of Hidalgo County, Texas. The court sentenced Luna to five years imprisonment in TDCJ and ordered her to pay court costs.
- 4. The court ordered the sentences to run concurrently.
- 5. Luna is currently incarcerated at the Lucile Plane State Jail, a unit of TDCJ.

#### **Legal Allegations**

- 1. Luna has committed acts for which a license holder may be disciplined under TEX. INS. CODE § 4005.101, as contemplated in TEX. INS. CODE § 4005.102.
- 2. Luna has been convicted of a felony, in violation of Tex. INS. CODE § 4005.101(b)(8).
- 3. Luna has been imprisoned following a felony conviction, resulting in revocation of her license by operation of law, pursuant to Tex. Occ. Code § 53.021(b).

### **Relief Sought**

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. revoking Luna's license and
- 2. imposing any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.
